This application contains subject matter related to the following pending U.S. design patent application:

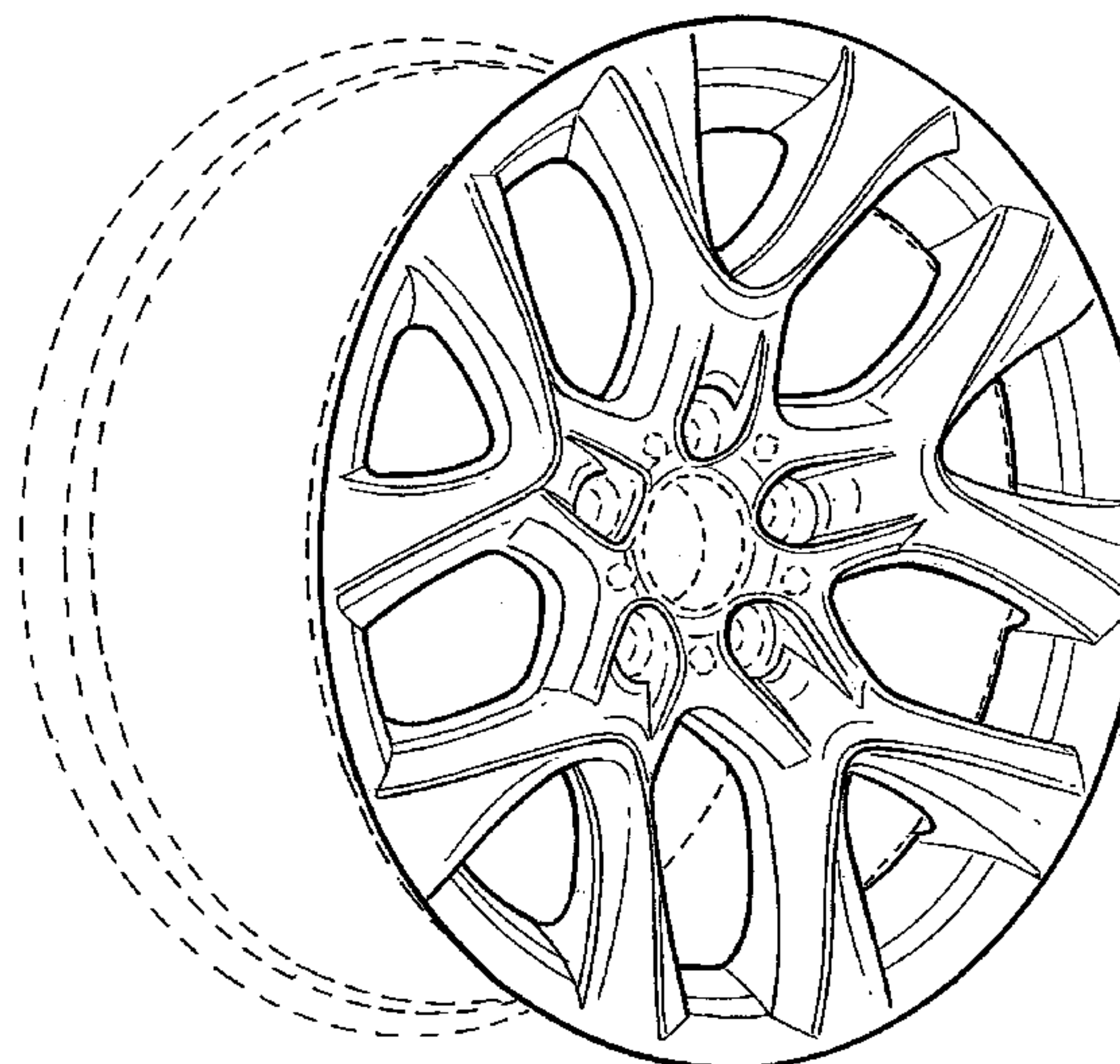
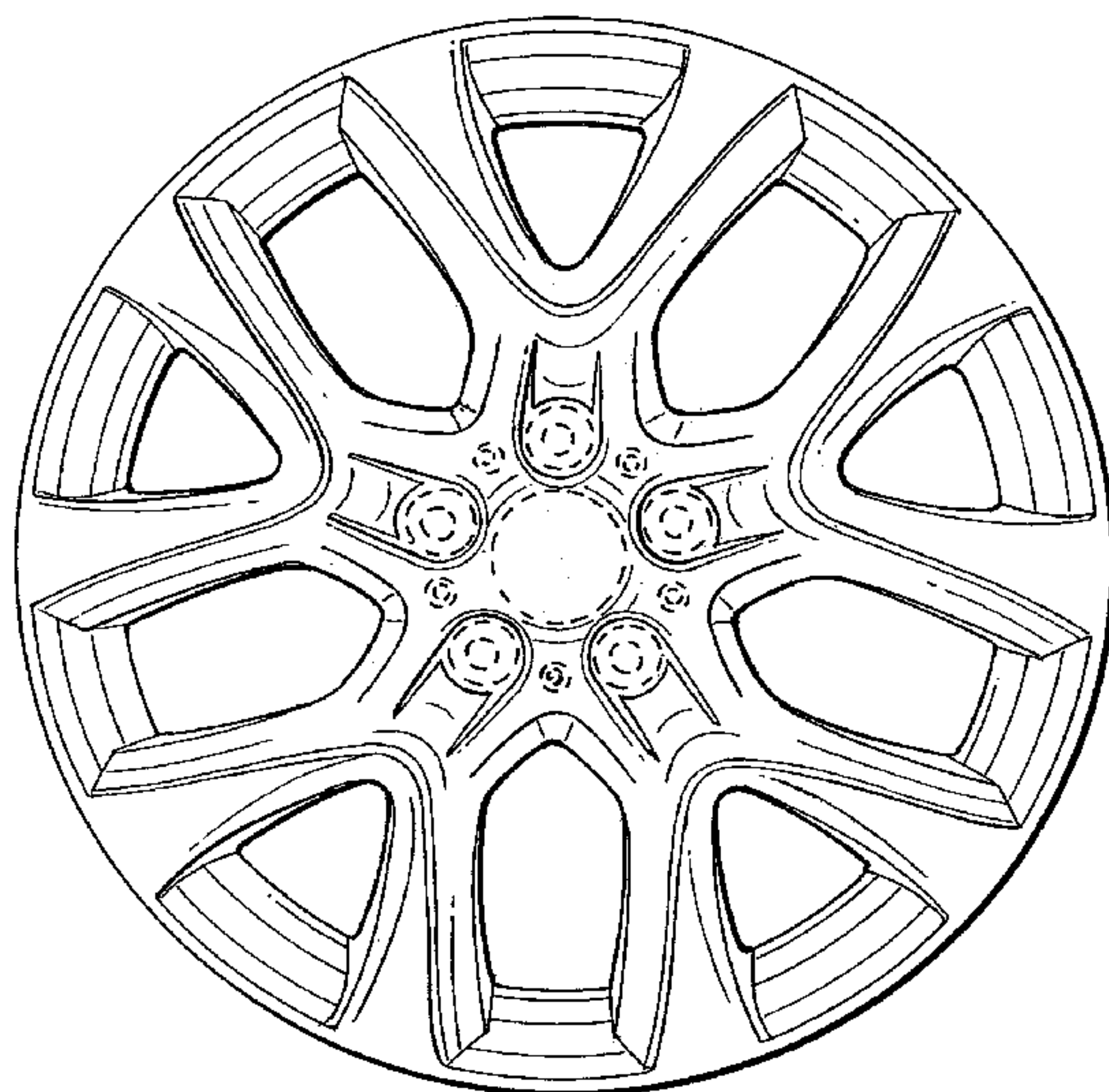

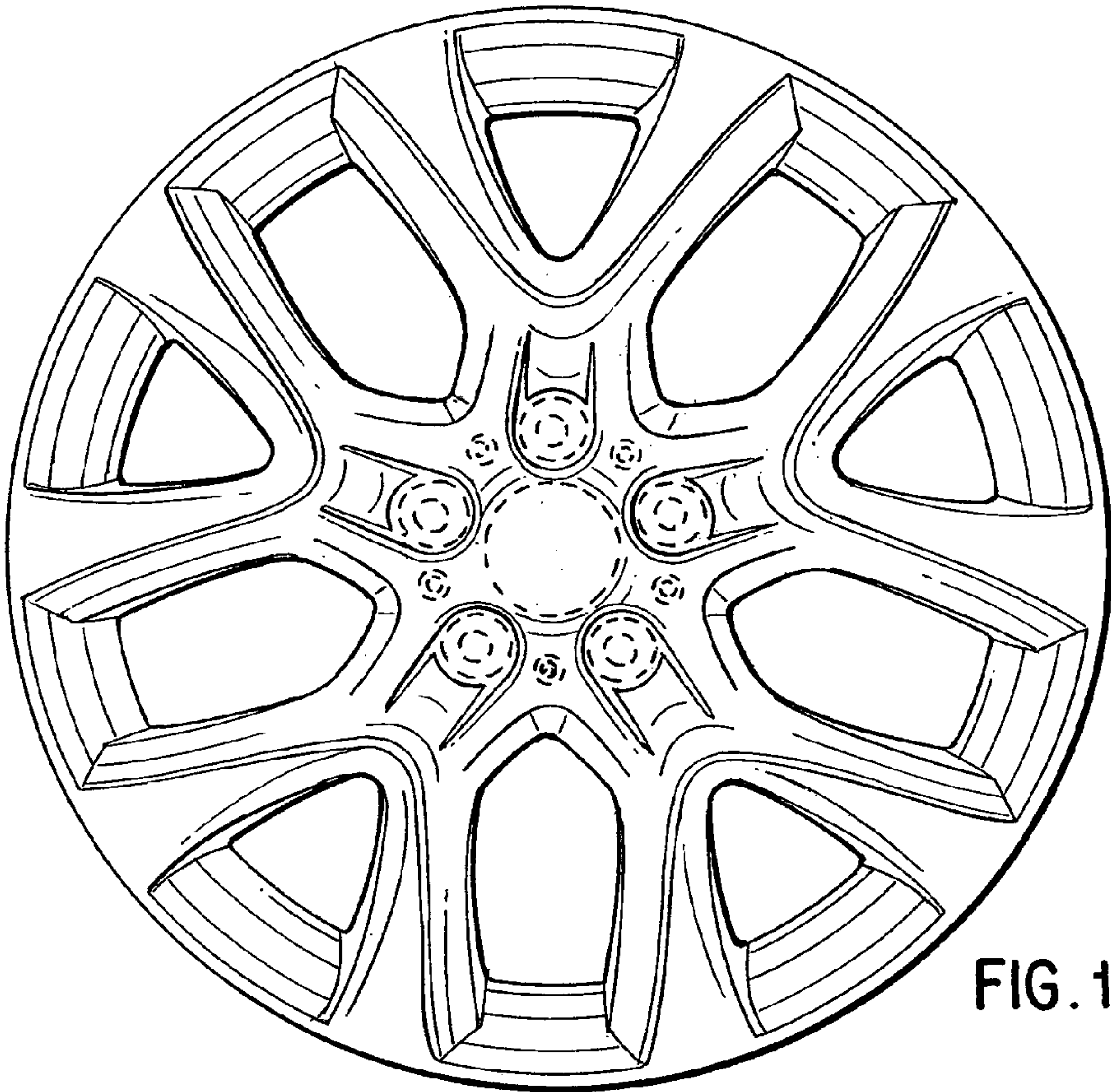

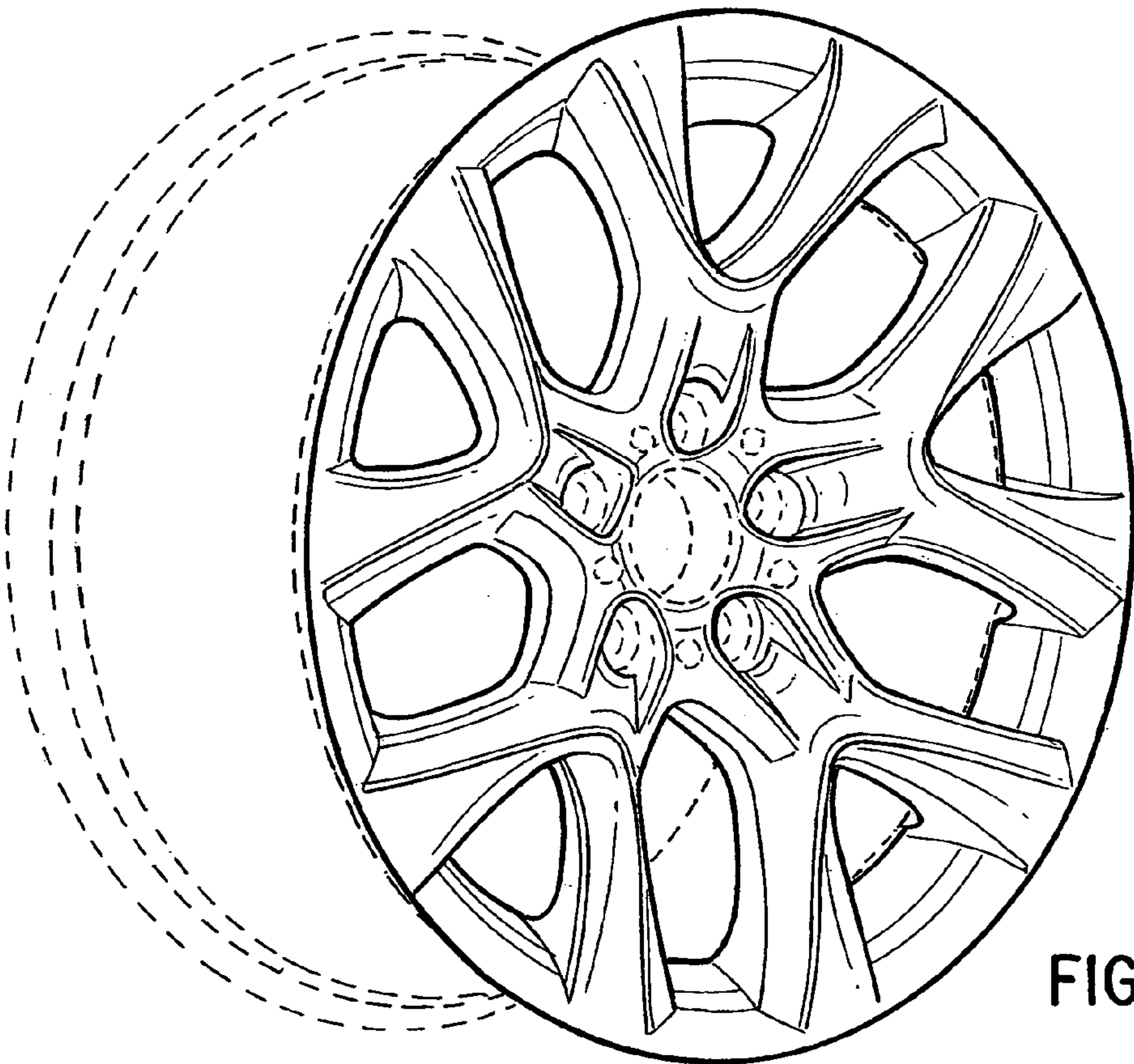
