(57) **CLAIM**

The ornamental design for a mounted cup holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cup holder in use embedded in luggage;

FIG. 2 is a front view of the holder embedded in luggage in closed condition;

FIG. 3 is an enlarged perspective view of the holder in closed condition;

FIG. 4 is an enlarged perspective view of the holder in open condition;

FIG. 5 is an enlarged front view of the holder in open condition;

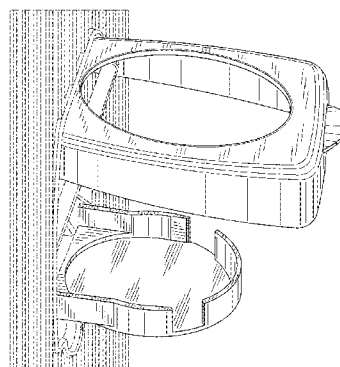
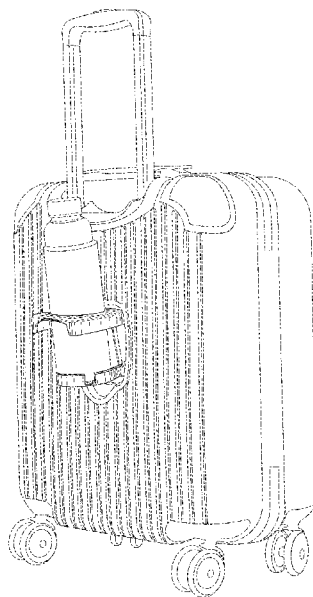
FIG. 6 is an enlarged right side view of the holder in open condition (the left side being a mirror image);

FIG. 7 is an enlarged top view of the holder in open condition; and,

FIG. 8 is an enlarged bottom view of the holder in open condition.

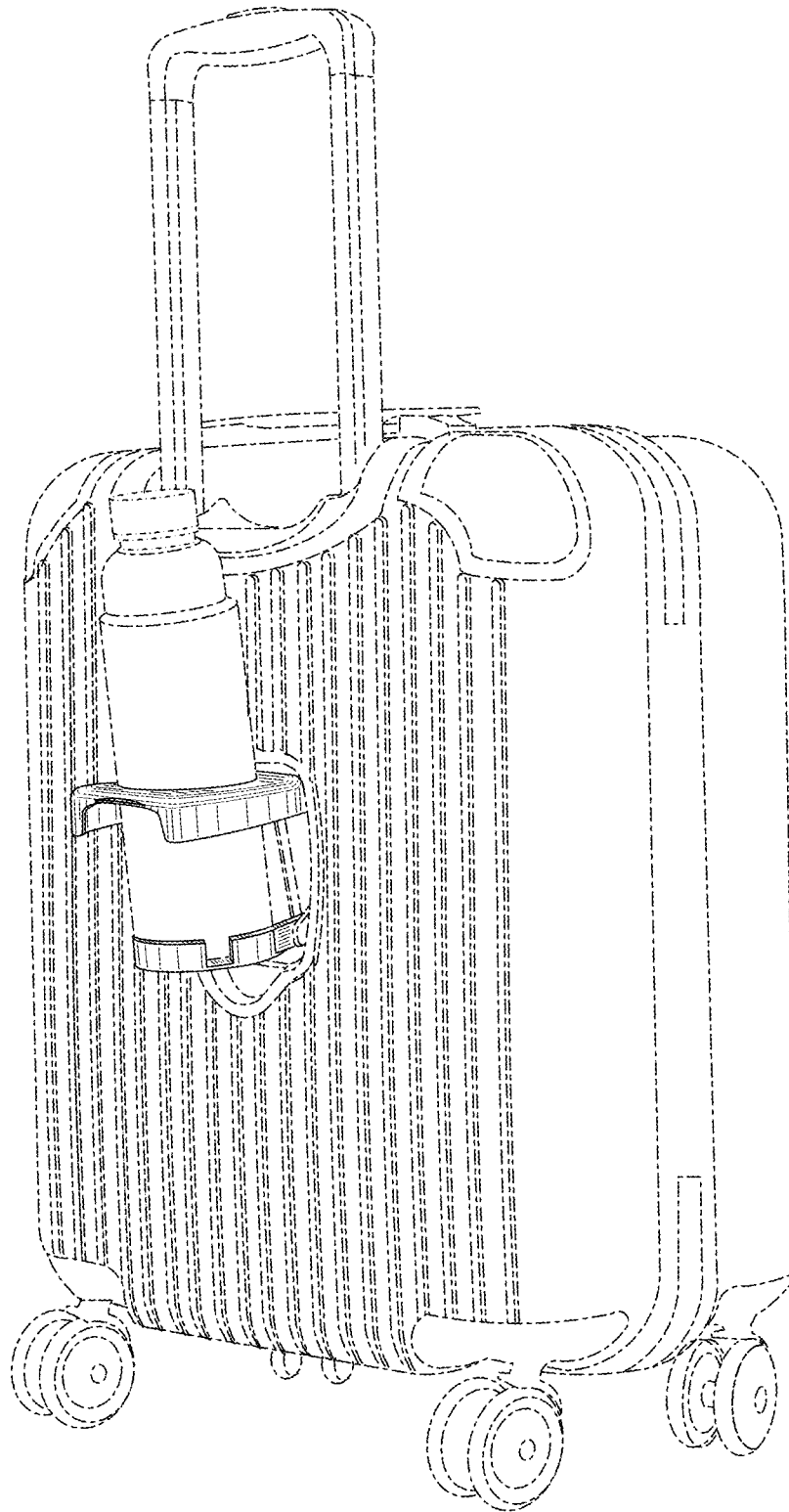

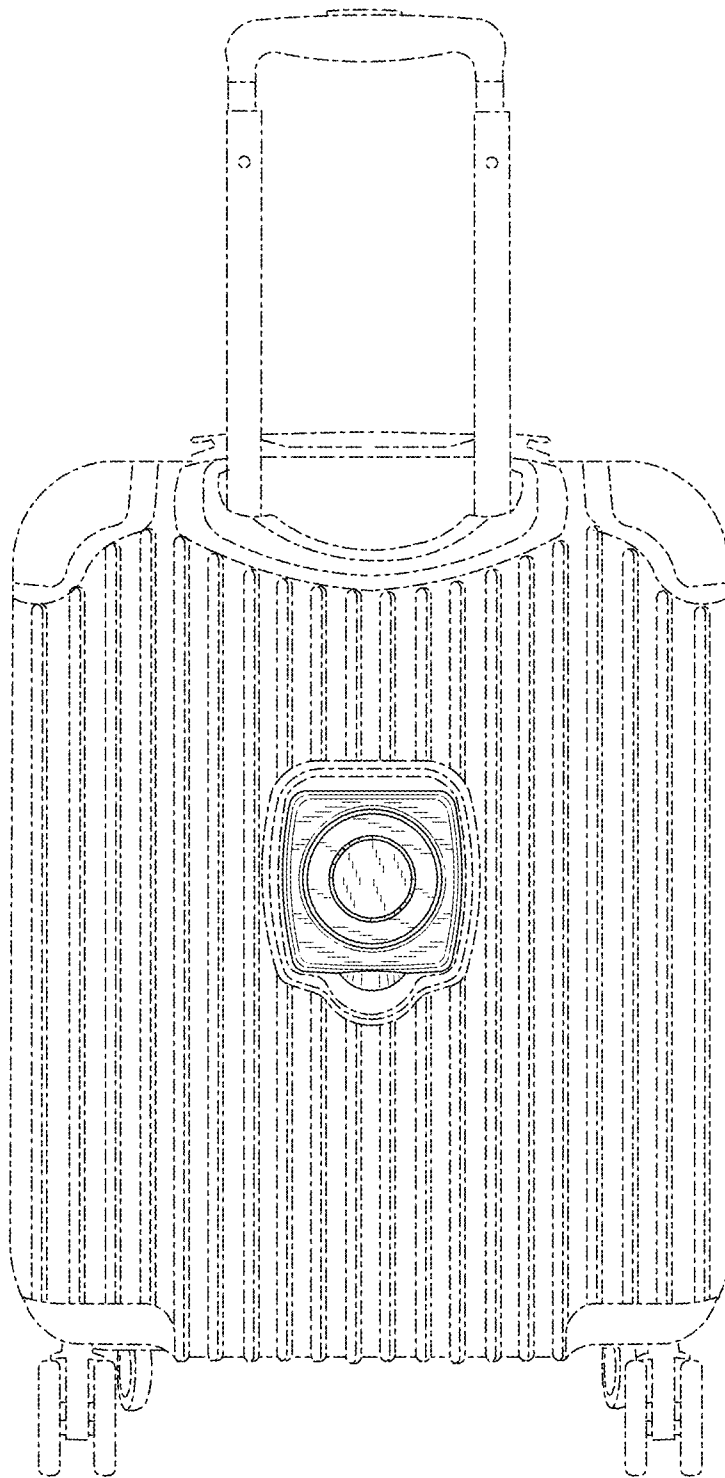

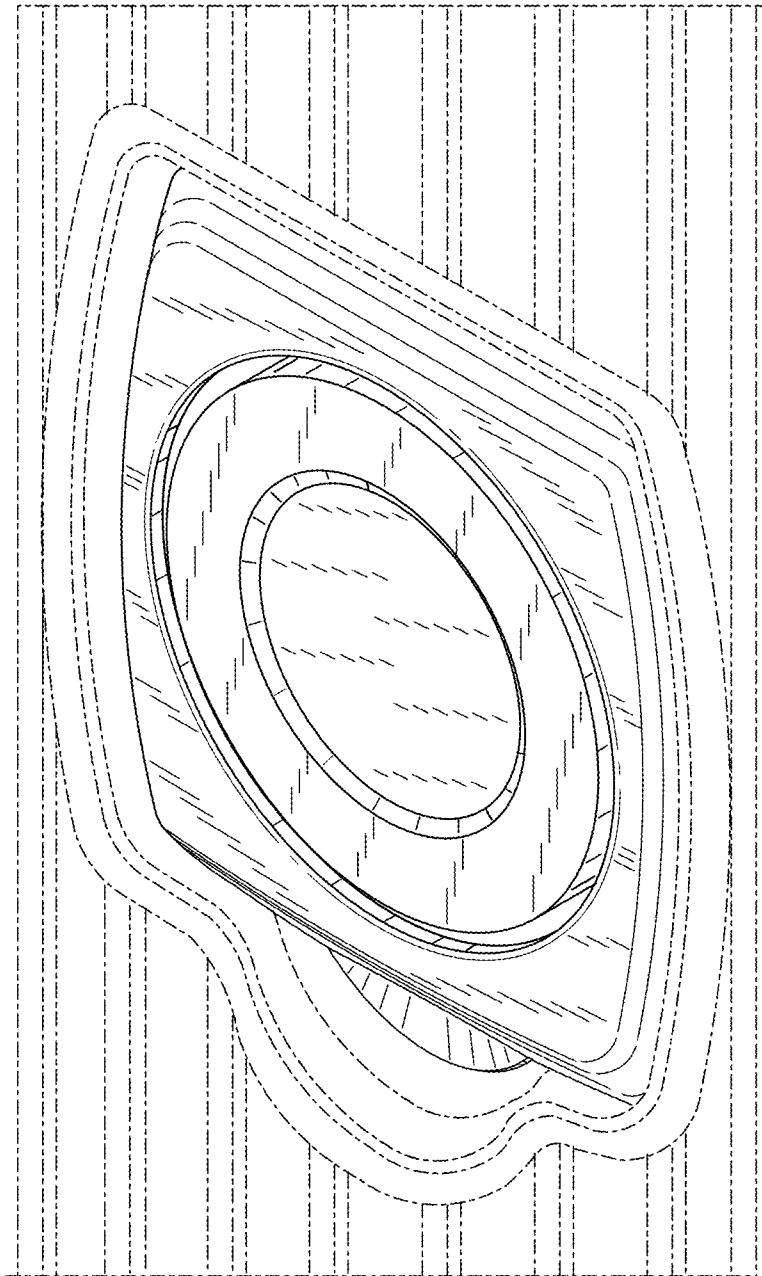

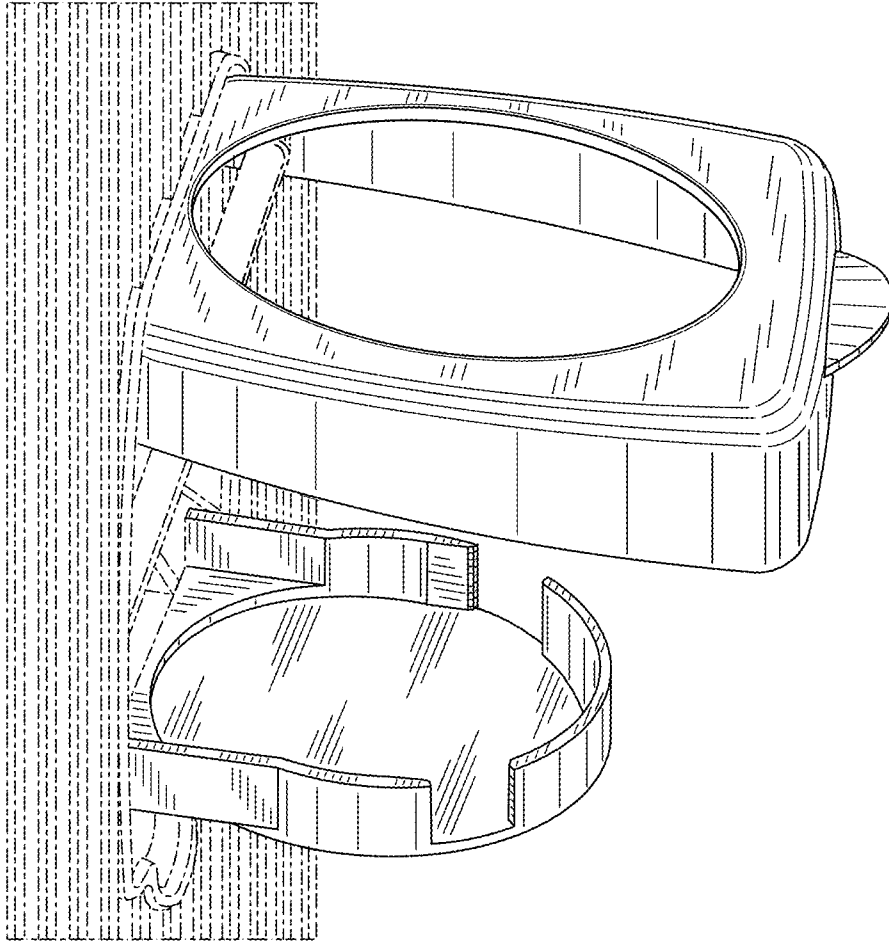

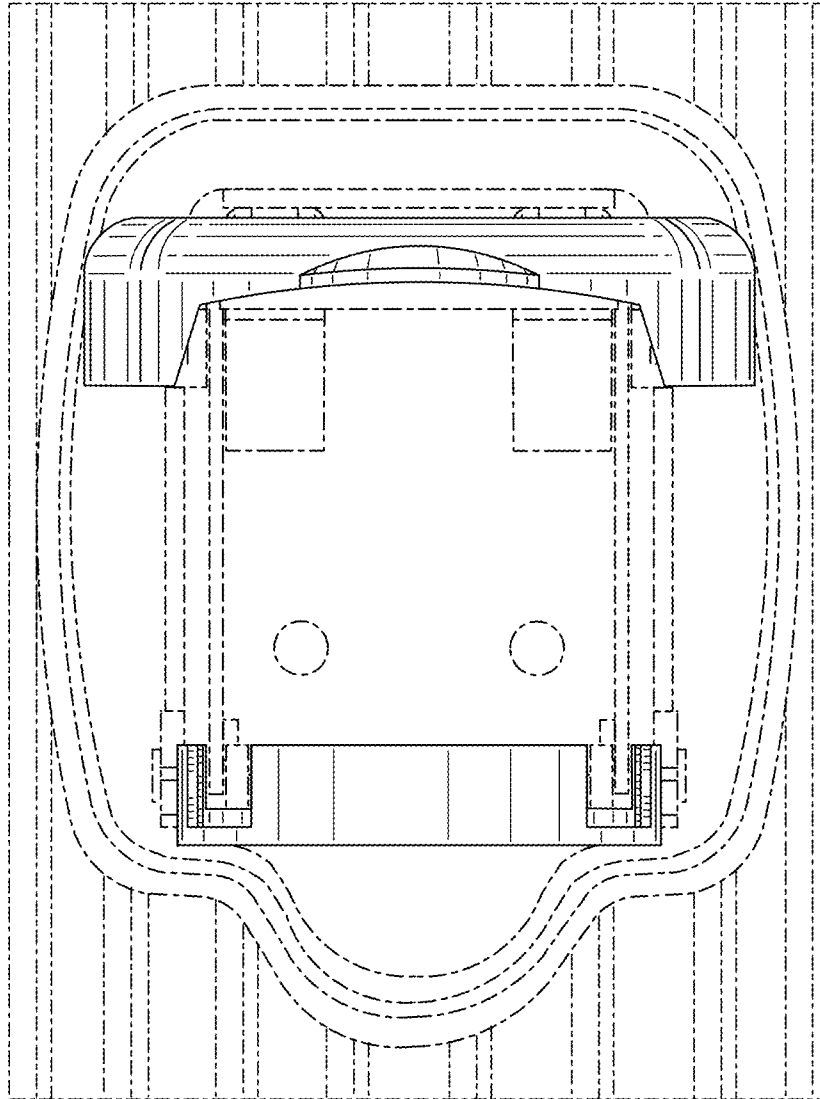

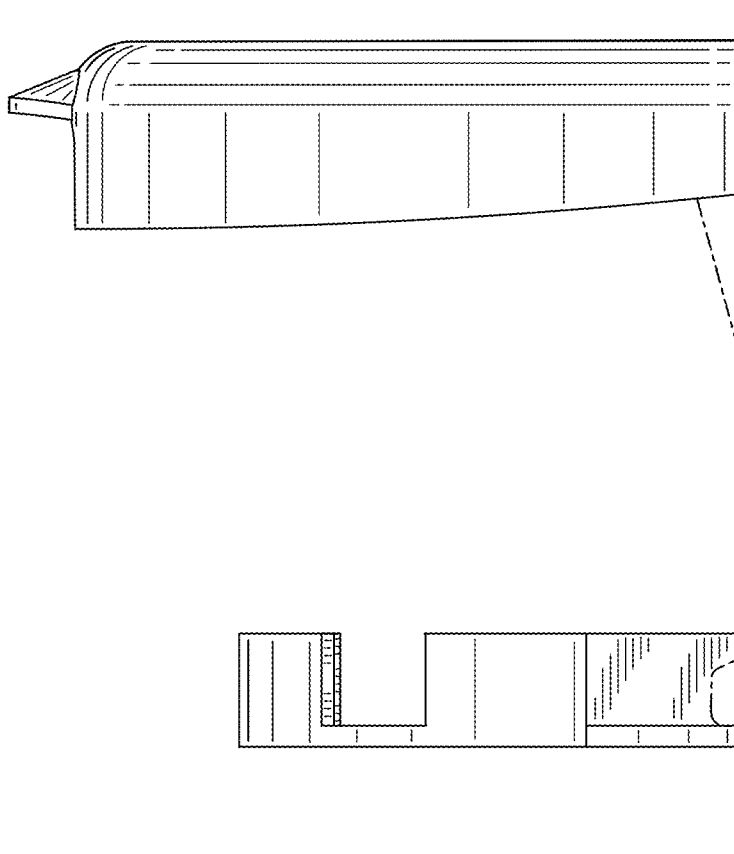

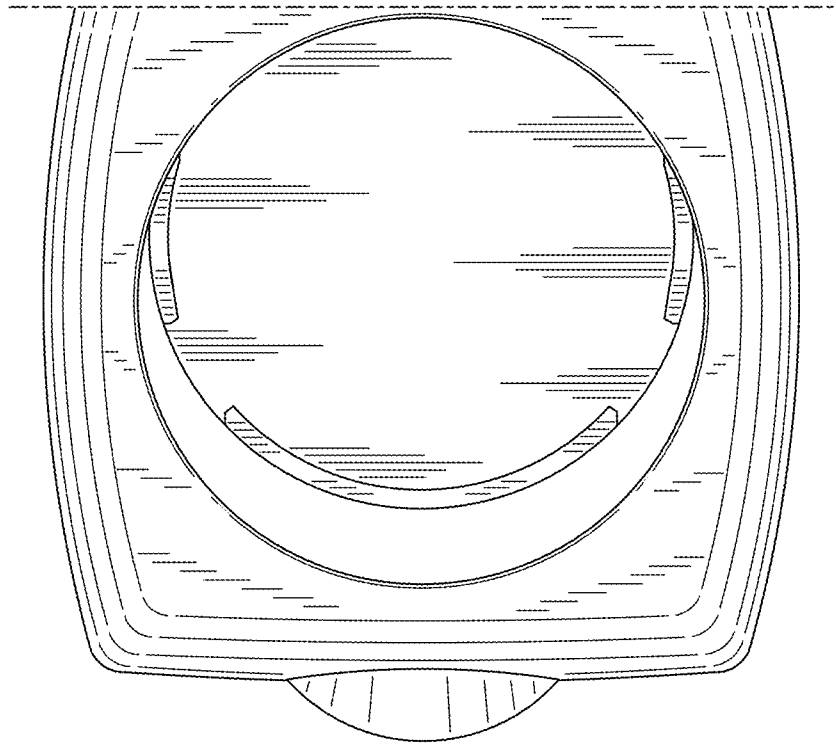

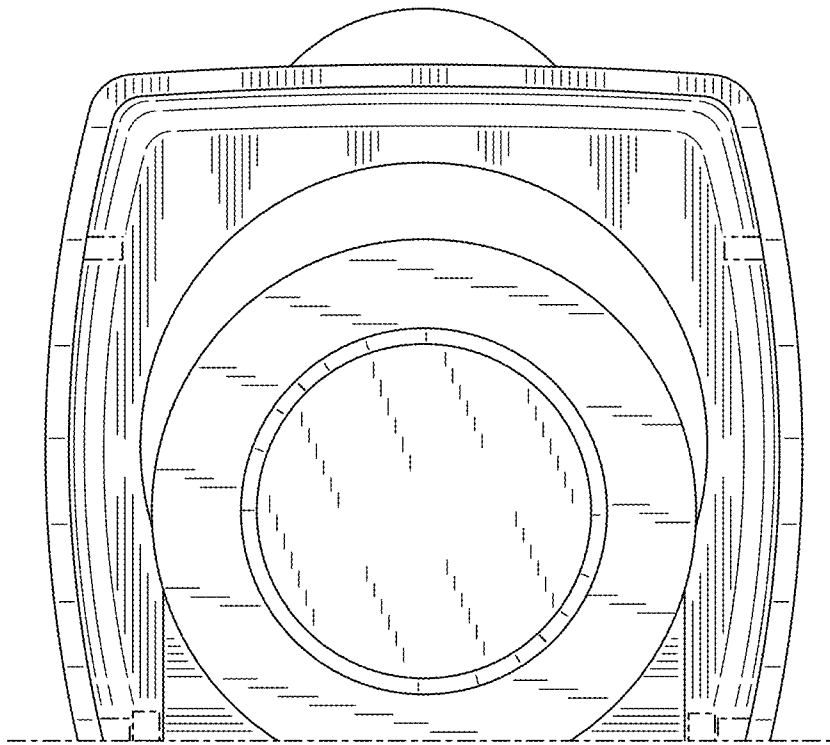
