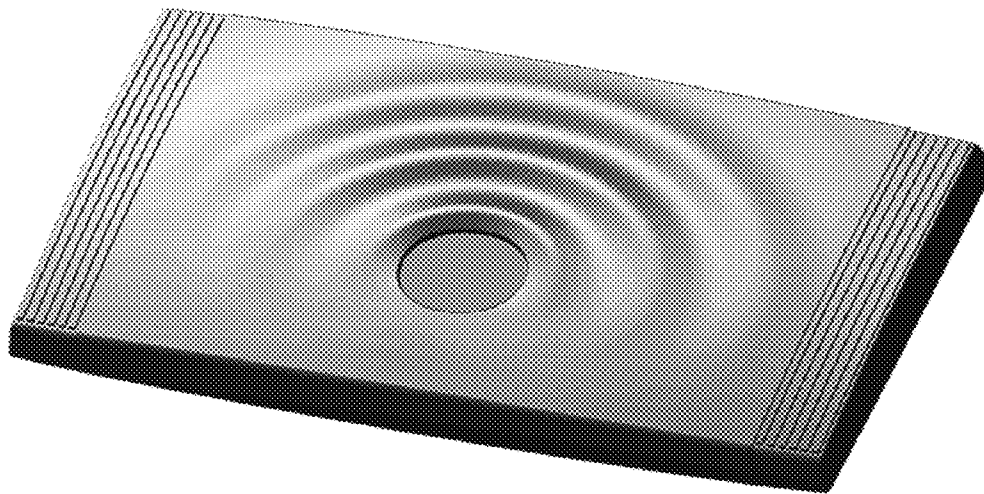
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an inverter cover for an automobile showing my new design;

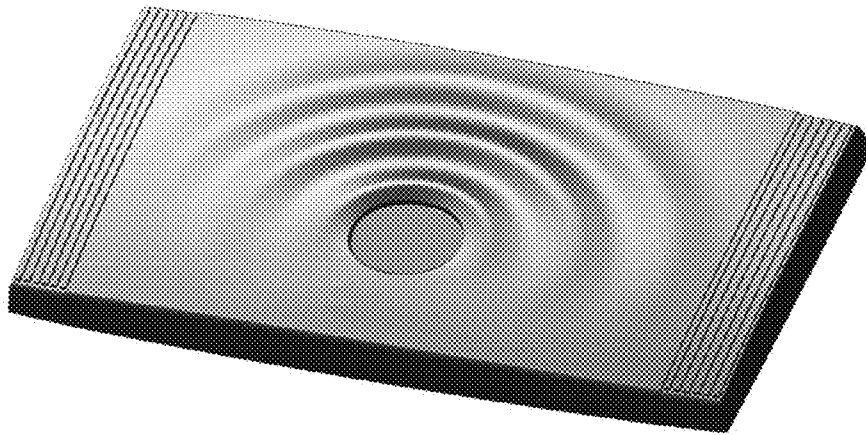

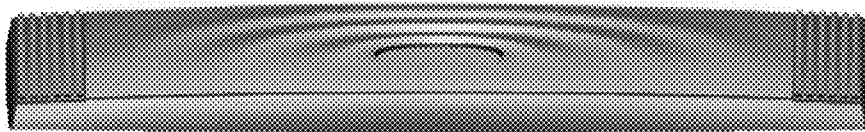

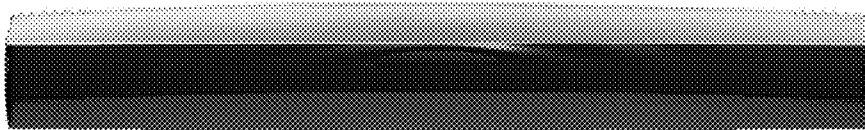

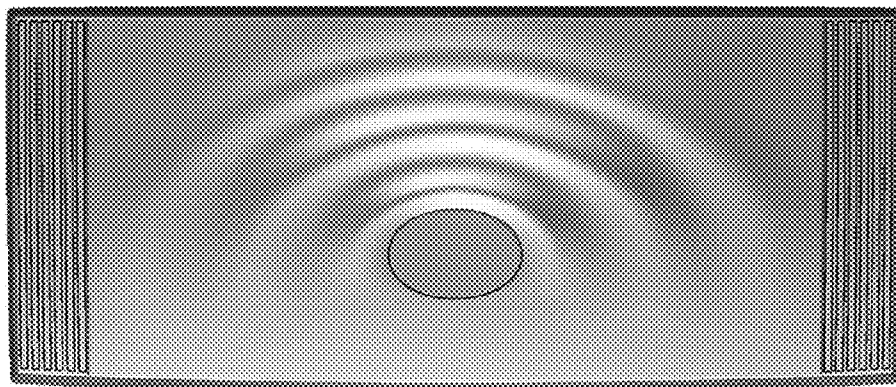

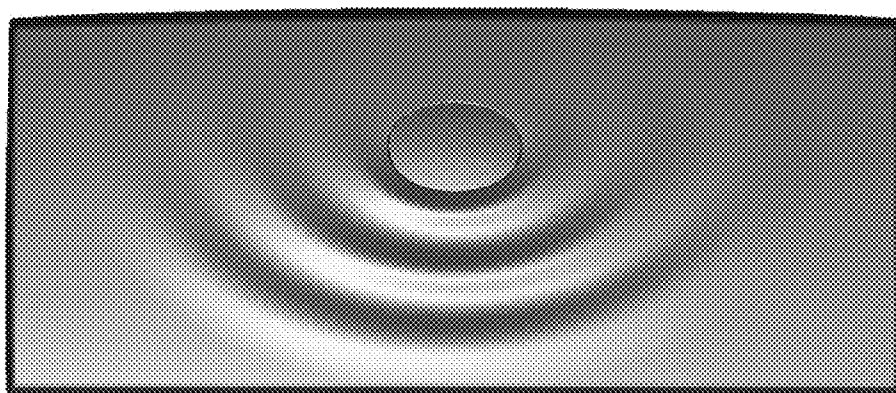

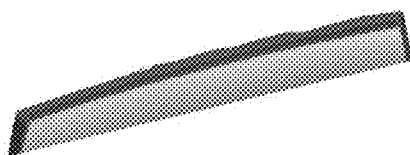

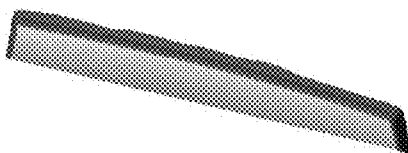
