DESCRIPTION

FIG. 1 is a perspective view of a toy animal, illustrated in a seated condition, showing my new design;
FIG. 2 is a front view thereof;

FIG. 4 is a first side view thereof;

FIG. 6 is a top plan view thereof;

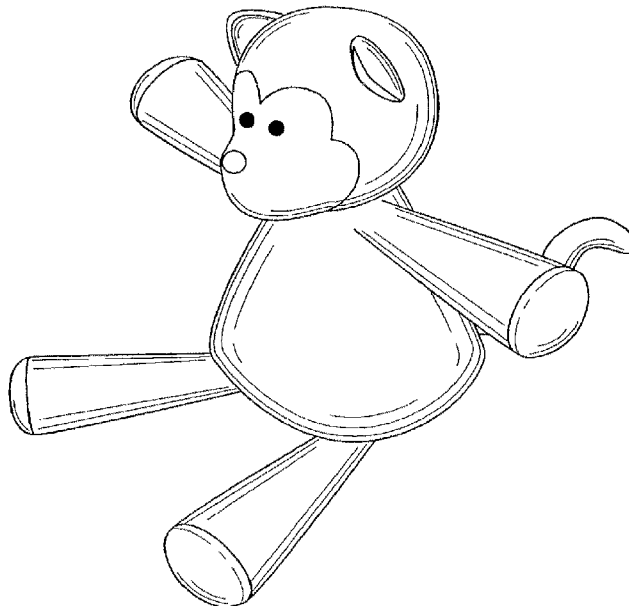

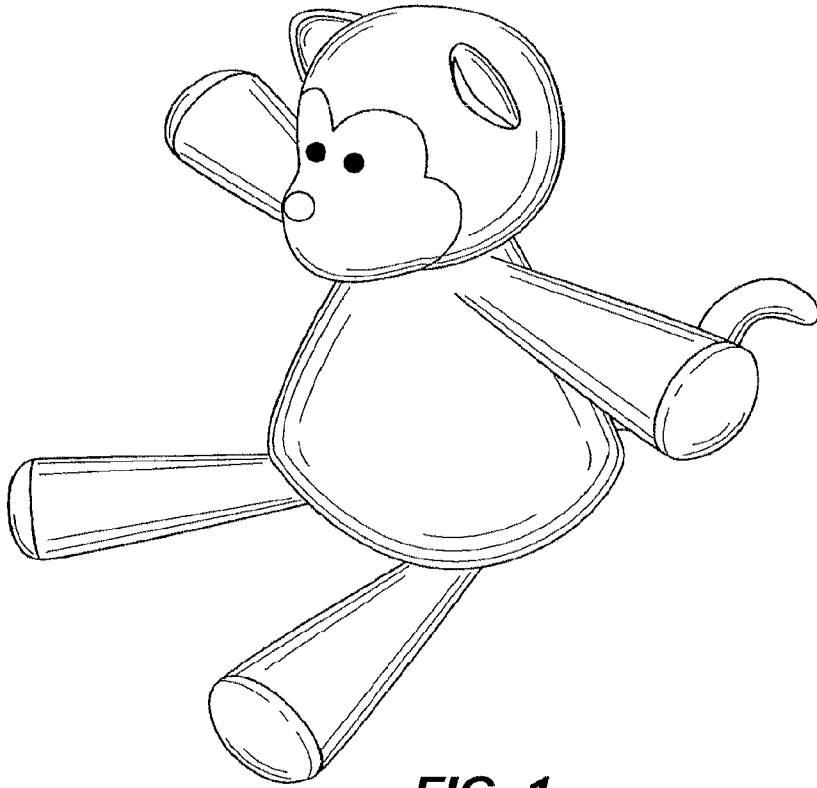

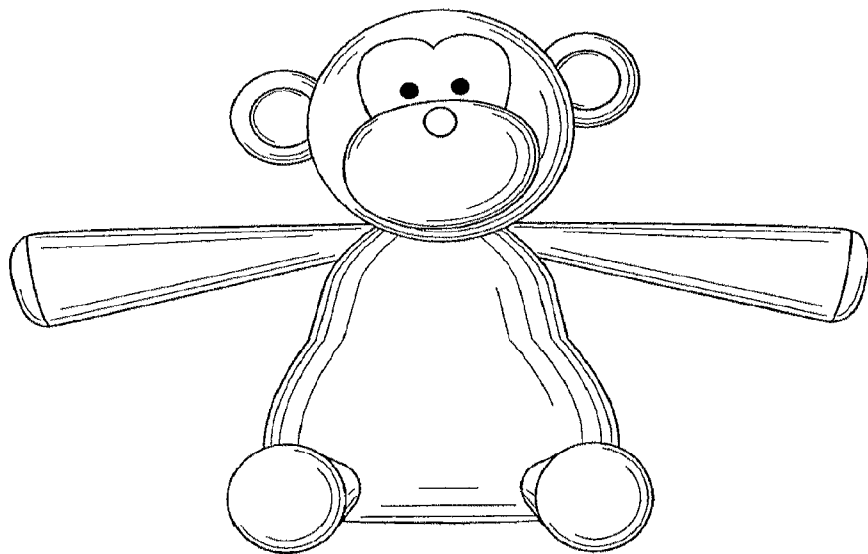

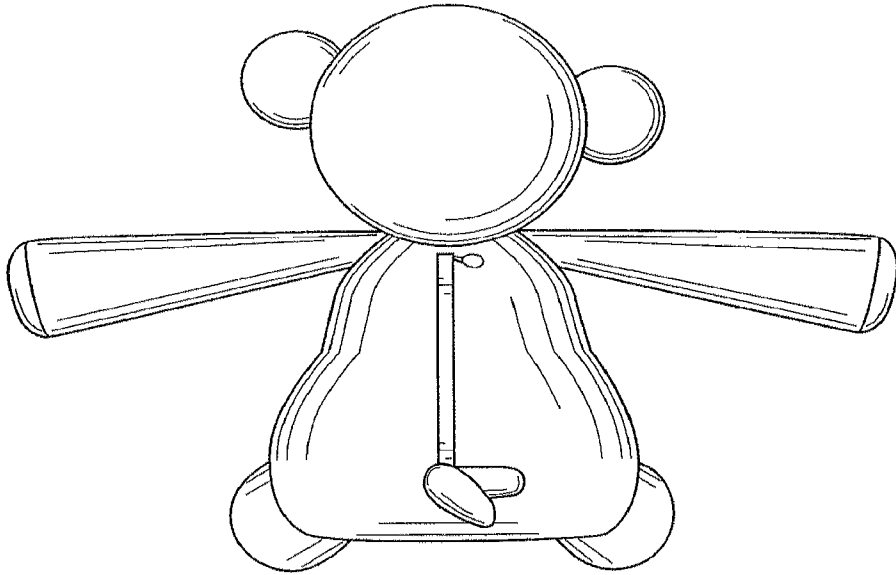

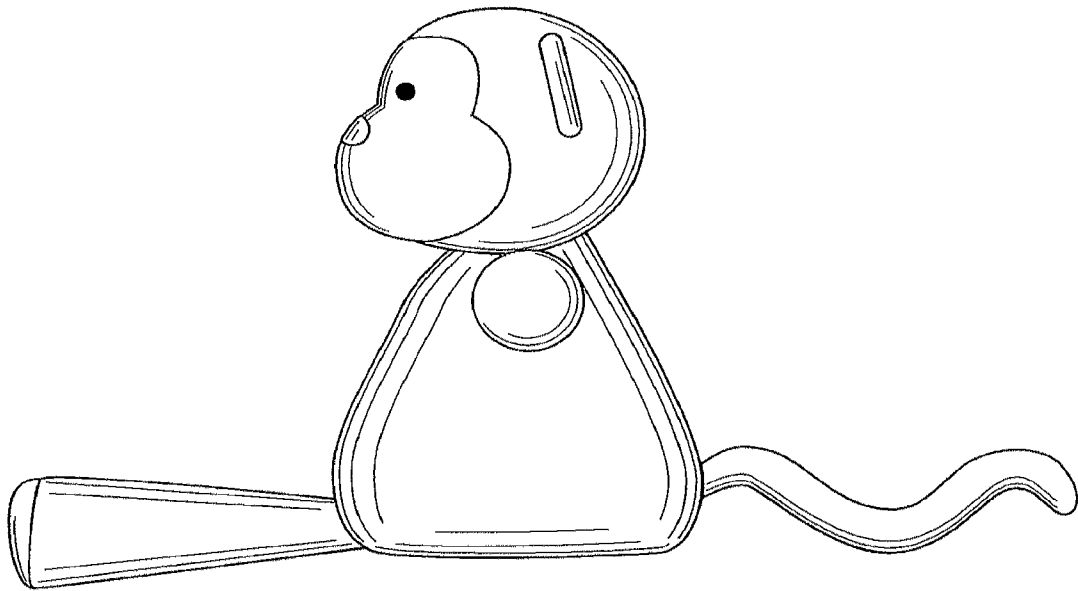

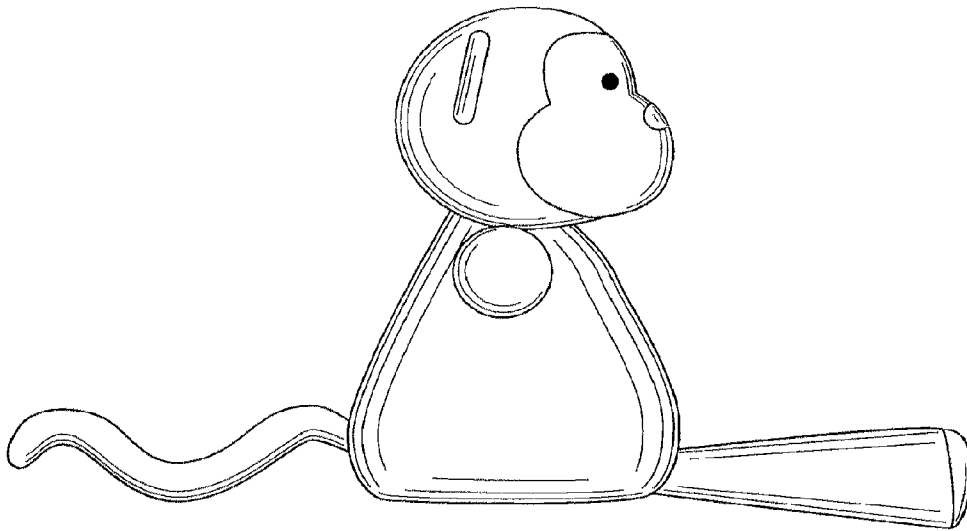

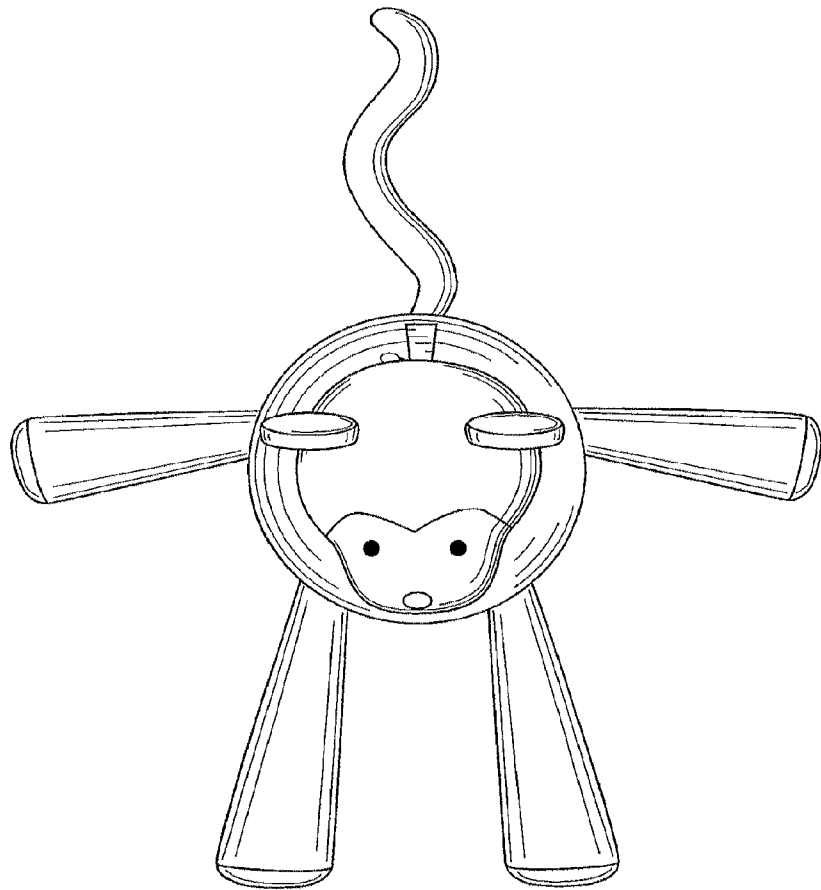

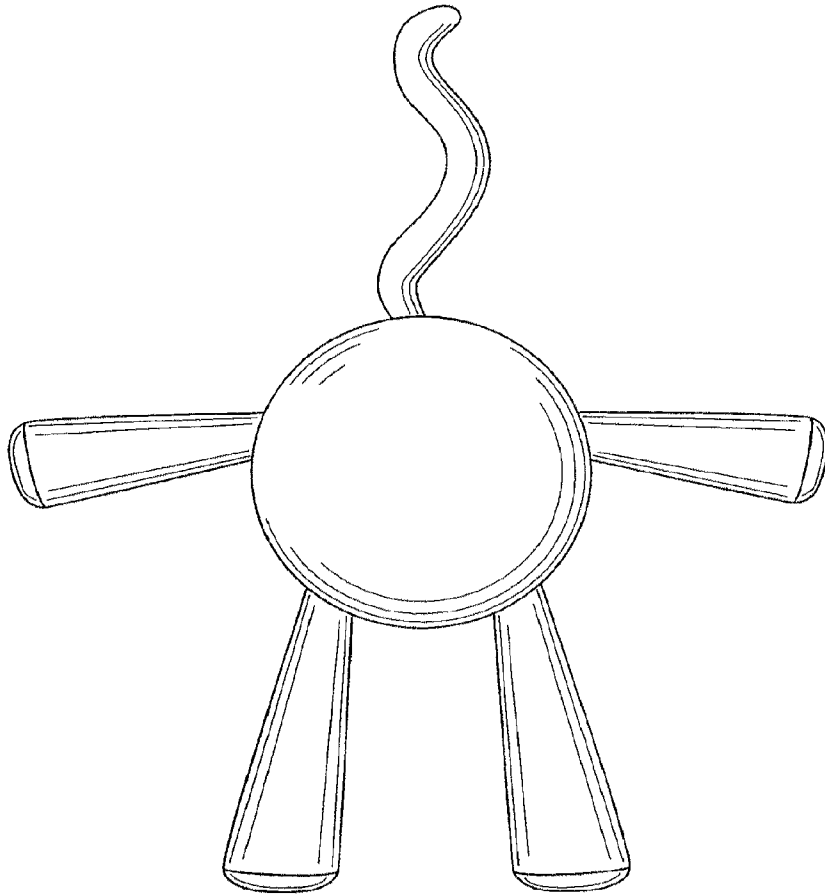

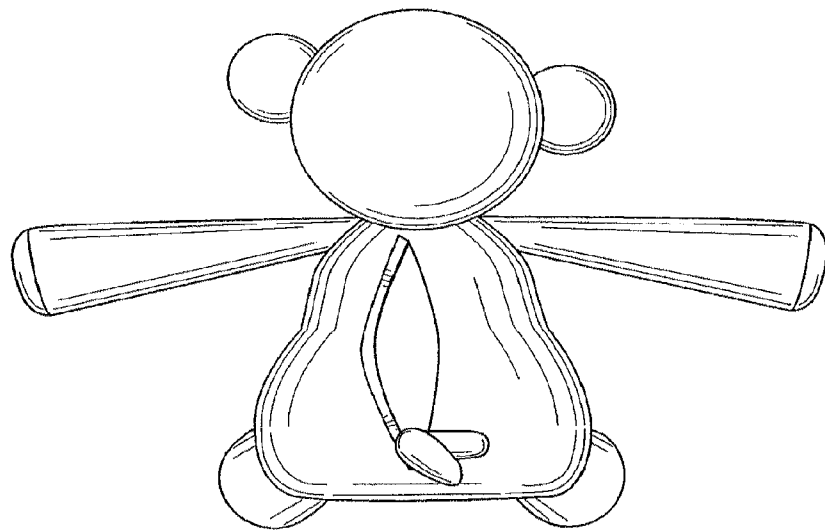

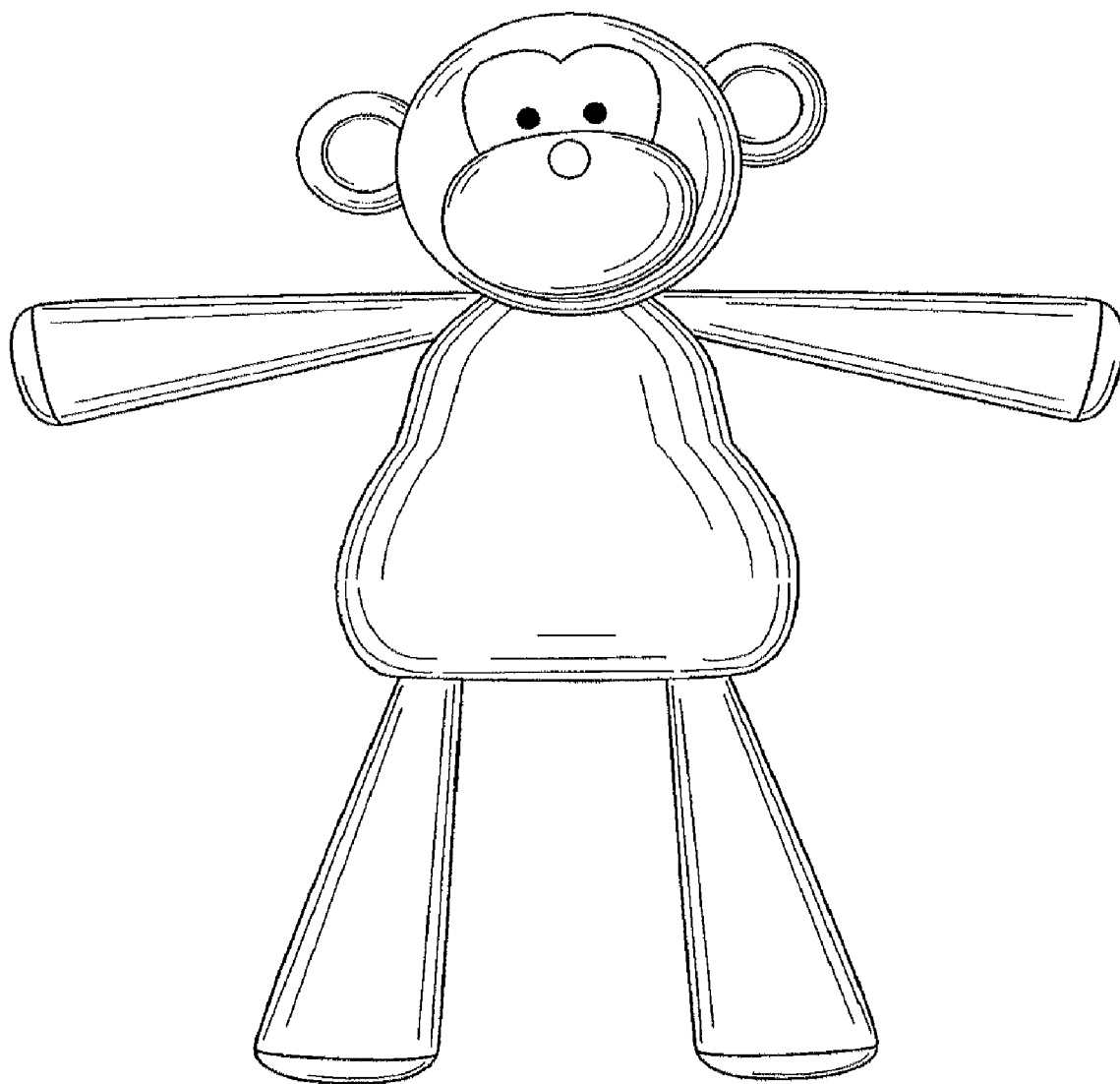
