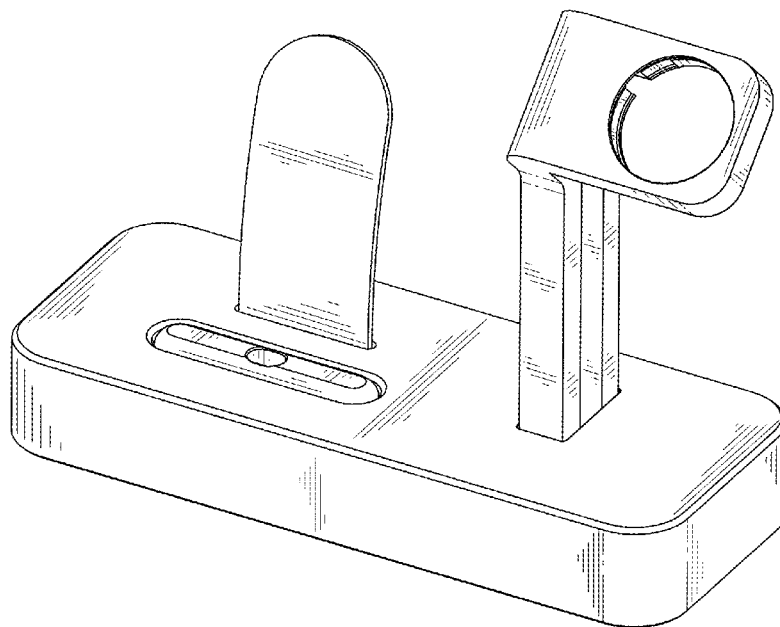
(57) **CLAIM**

The ornamental design for a charging stand for portable electronic devices, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a charging stand for portable electronic devices showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a perspective view showing the charging stand for portable electronic devices in a use state. The broken lines in the FIG. 9 depict electronic devices to be charged which form no part of the claimed design.

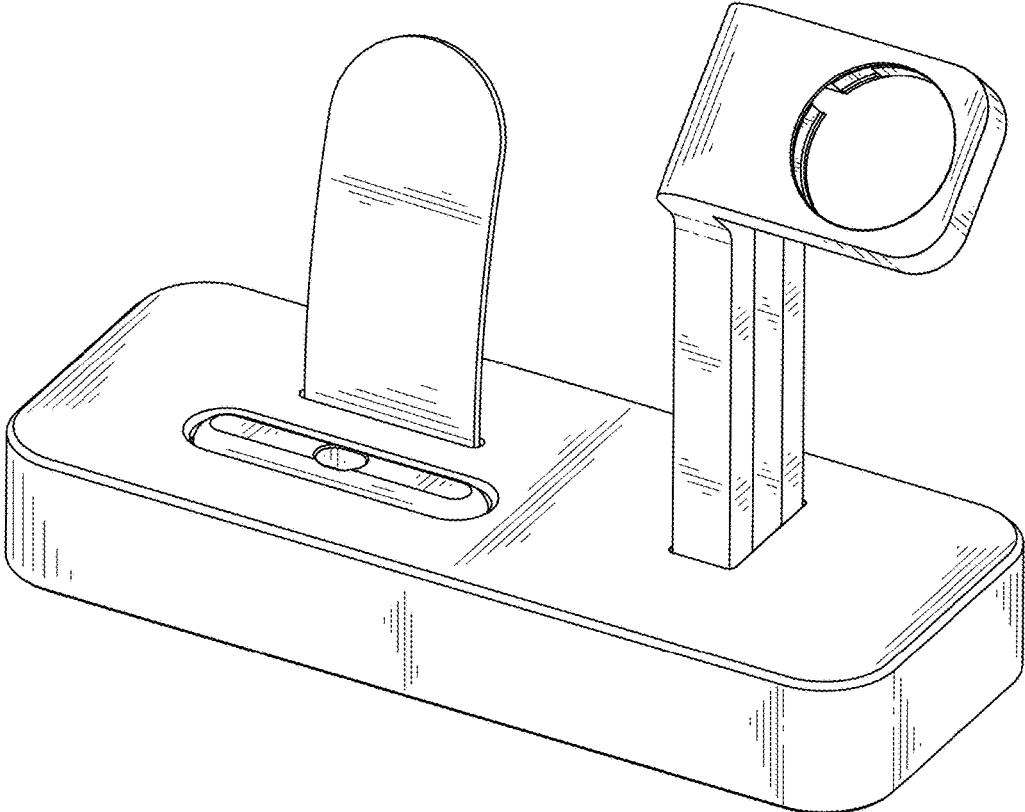

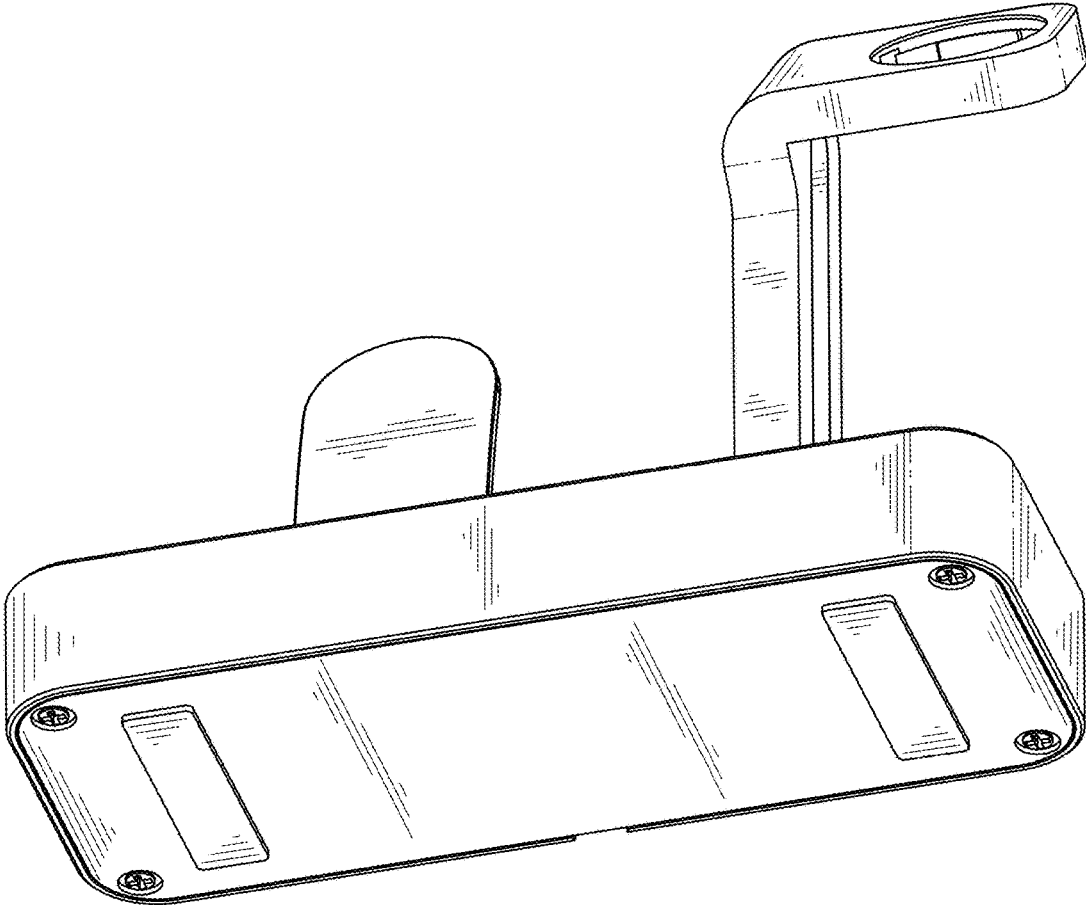

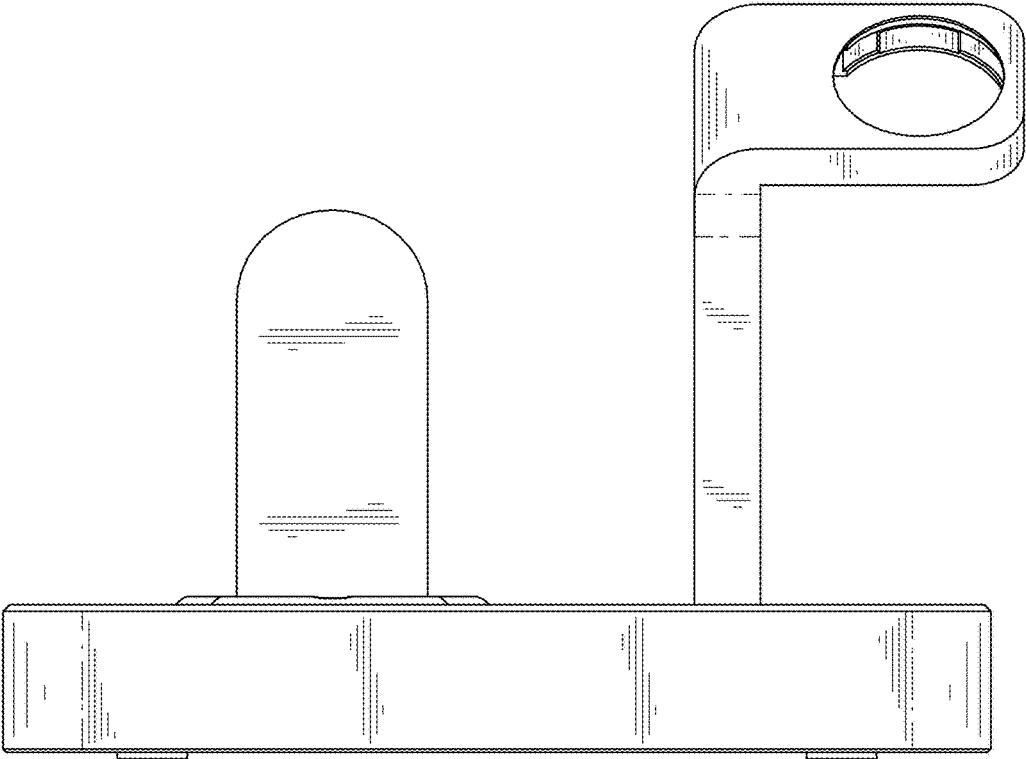

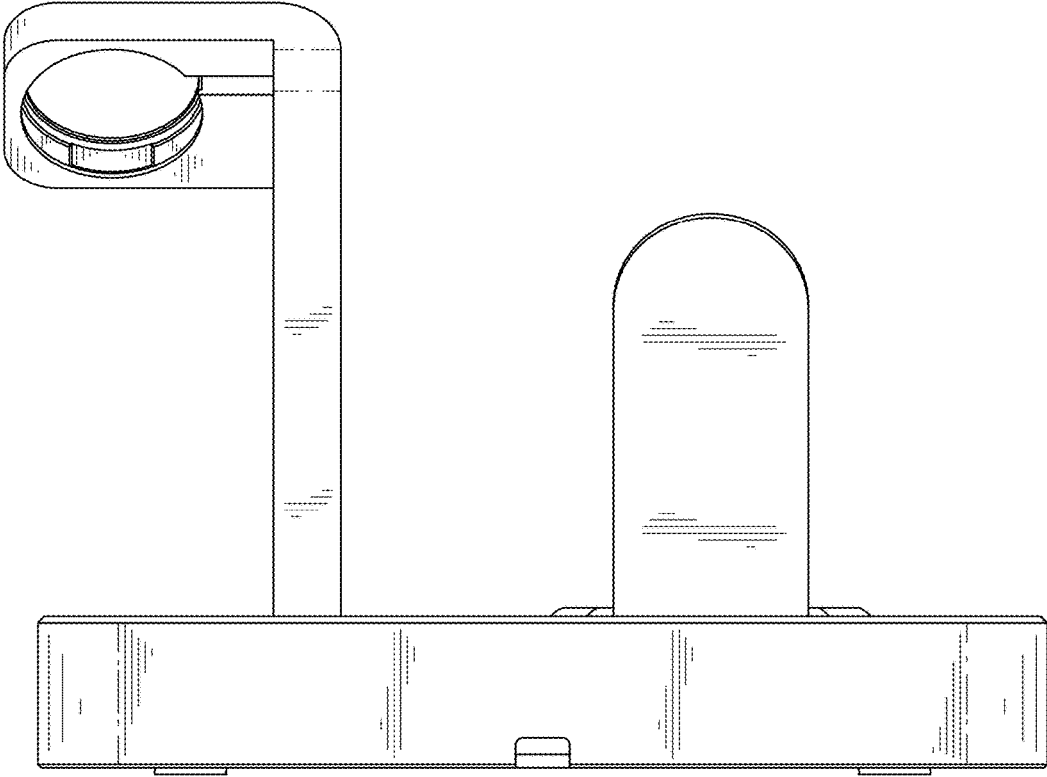

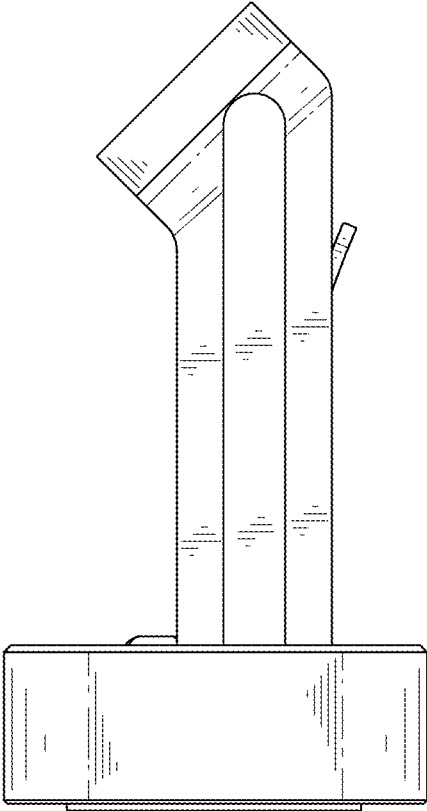

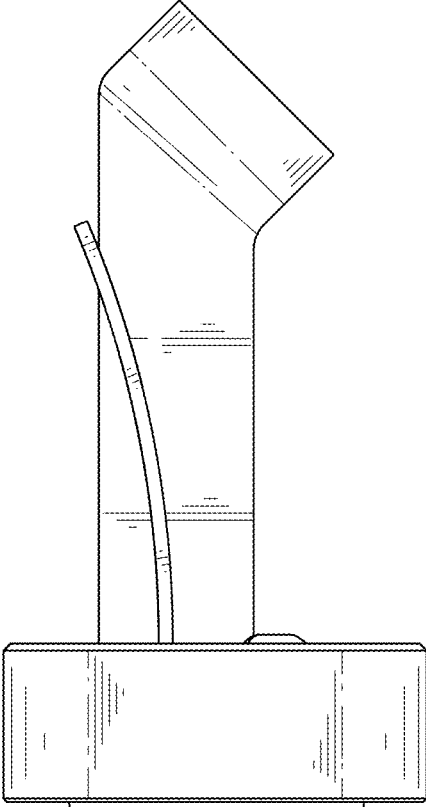

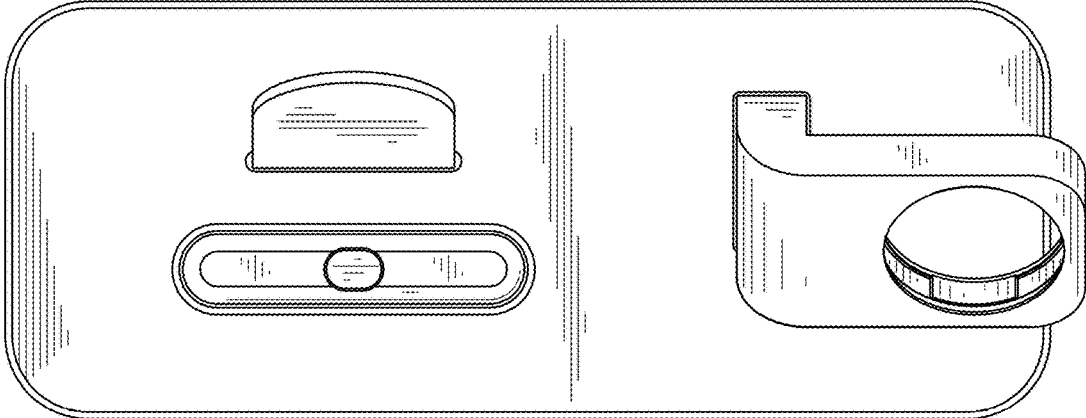

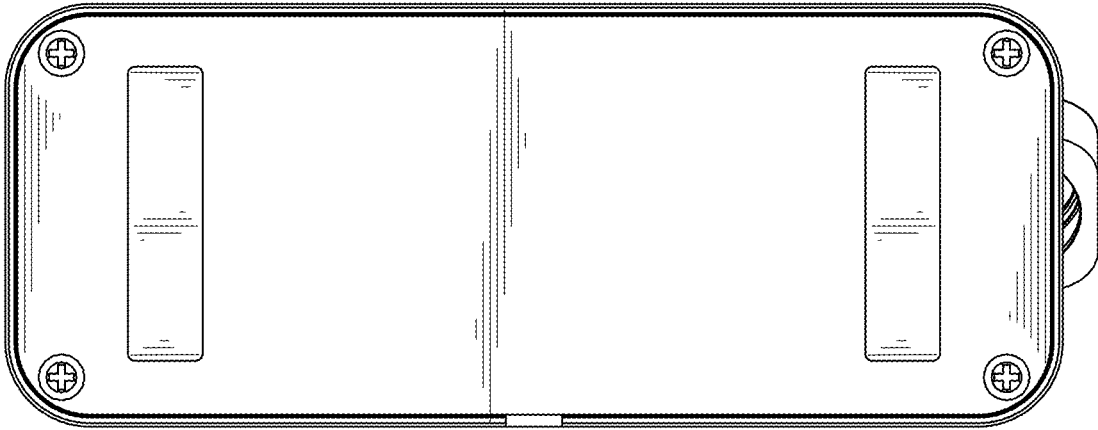

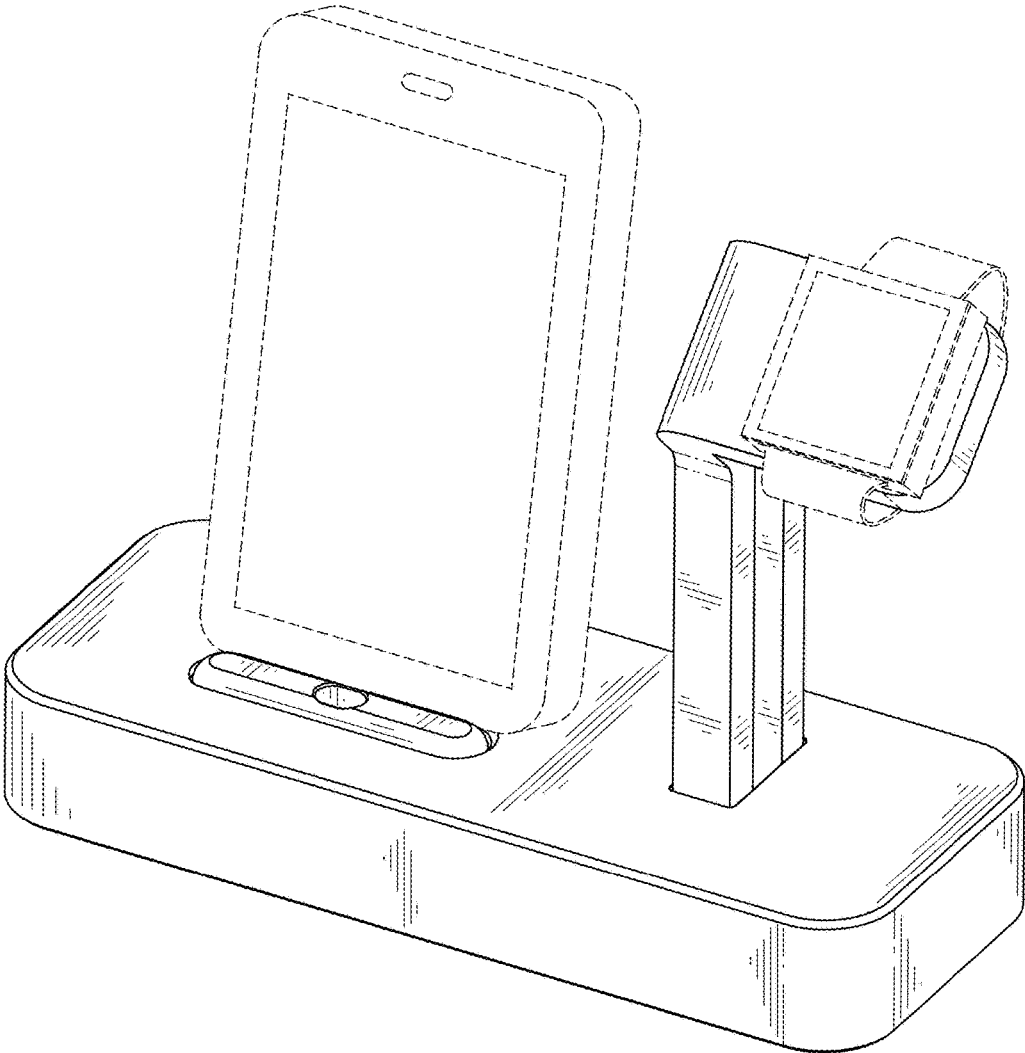
