**DESCRIPTION**

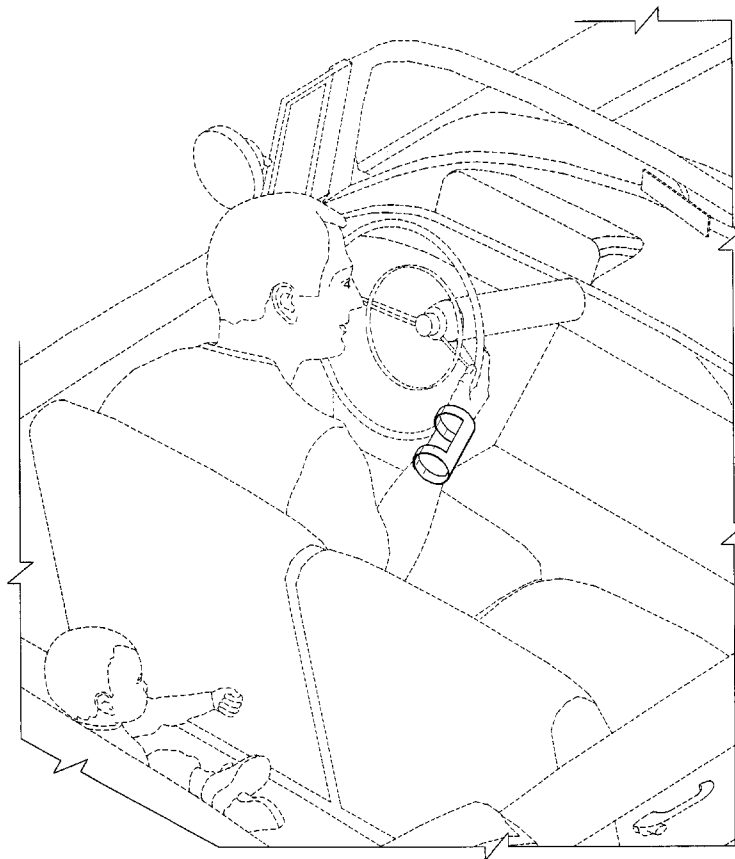
FIG. 1 is a perspective view of a baby on board wristband showing my new design; For ease of illustration the text has been omitted,

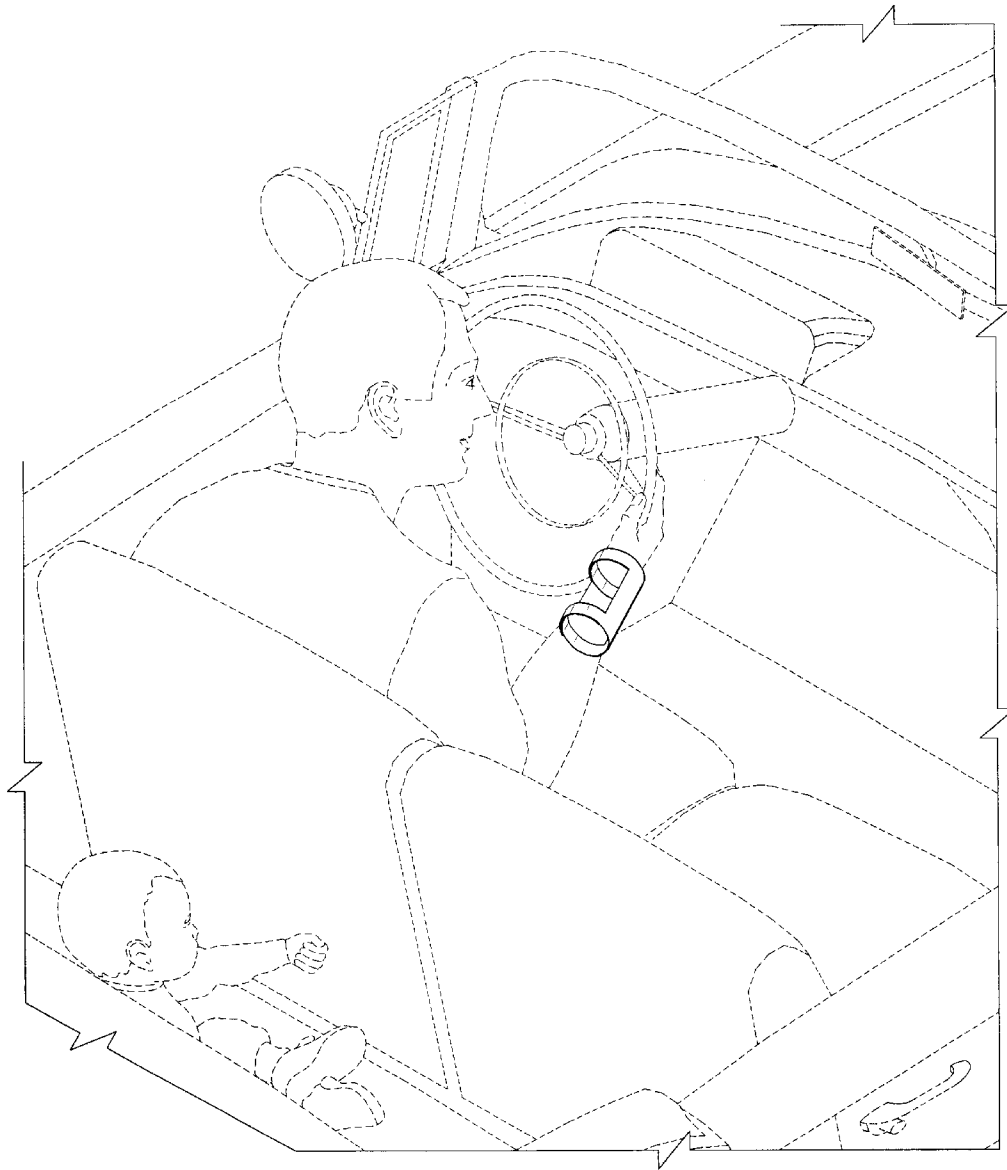
FIG. 2 is a perspective view thereof; and,

FIG. 3 is a top plan view thereof.

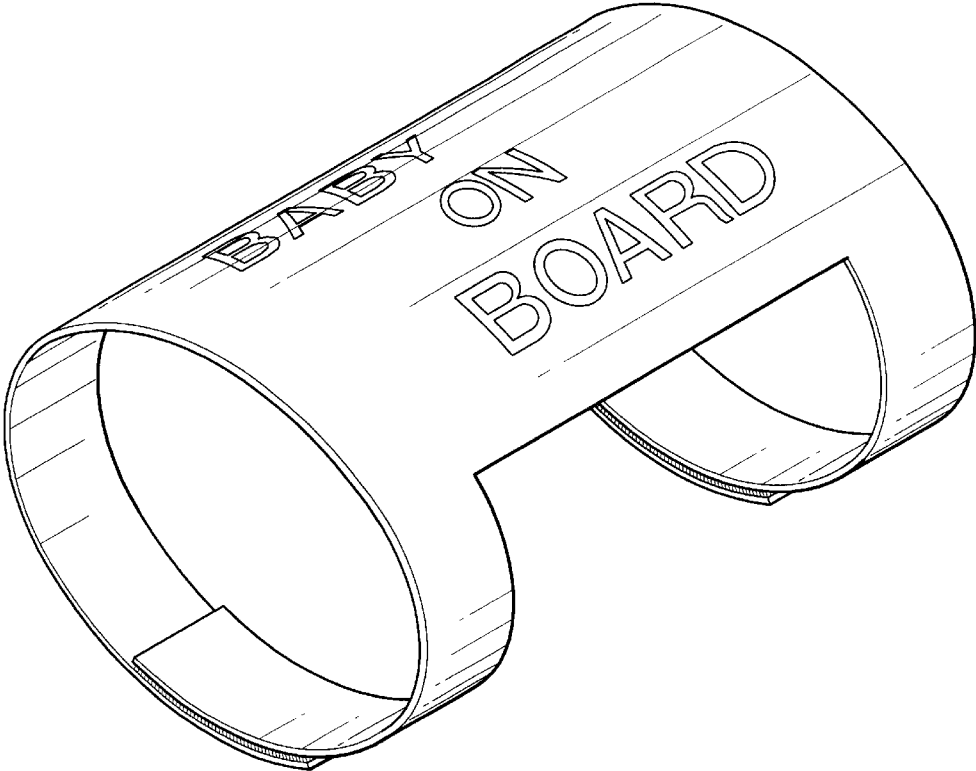
The automobile and other structure shown in broken lines in FIG. 1 represents environmental features that are not part of the design sought to be patented.

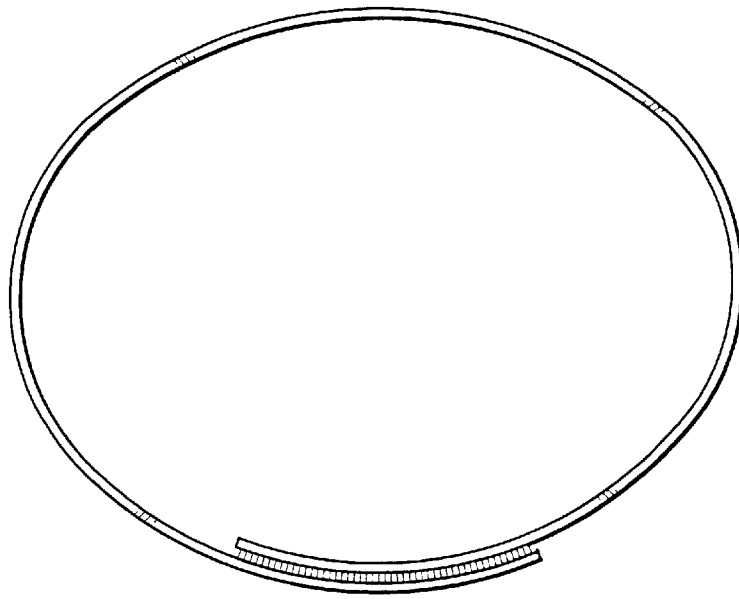
