

(57) **CLAIM**

I claim the ornamental design for a portion of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a left, front, top perspective view of a portion of a shoe upper showing my new design;  
FIG. 2 is a right elevational view thereof;  
FIG. 3 is a left elevational view thereof;  
FIG. 4 is a top plan view thereof;












