(57) **CLAIM**


The ornamental design for a tide powered electricity gener-
ating system, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tide powered electricity generating system showing my new design;
 FIG. 2 is a left side view of the tide powered electricity generating system;
 FIG. 3 is a top view of the tide powered electricity generating system;
 FIG. 4 is a front view of the tide powered electricity generating system;
 FIG. 5 is a left side cross-section view along Line 5-5 of FIG. 3 depicting the tide powered electricity generating system in a high tide position;
 FIG. 6 is a front cross-section view along Line 6-6 of FIG. 3 depicting the tide powered electricity generating system in a high tide position;
 FIG. 7 is a front cross-section view along Line 7-7 of FIG. 3 depicting the tide powered electricity generating system in a low tide position; and,
 FIG. 8 is a left side cross-section view along Line 8-8 of FIG. 3 depicting the tide powered electricity generating system in a low tide position.

The right side view not shown is a mirror image of the left side view. The rear view not shown is a mirror image of the front view. The bottom view not shown does not form a part of the design sought to be patented. The broken lines shown represent environmental subject matter and form no part of the claimed design. Portions of the tide powered electricity generating system are shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.
















