I claim the novel design for a handbag, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of our new design for a handbag;

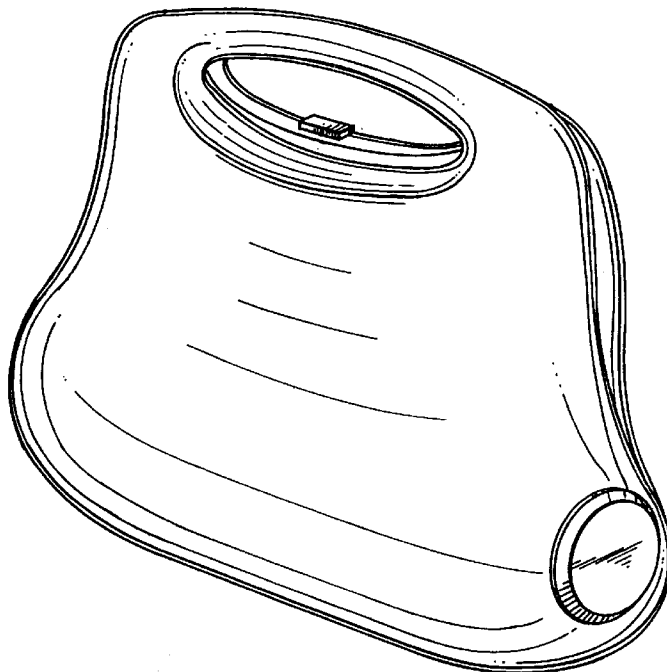

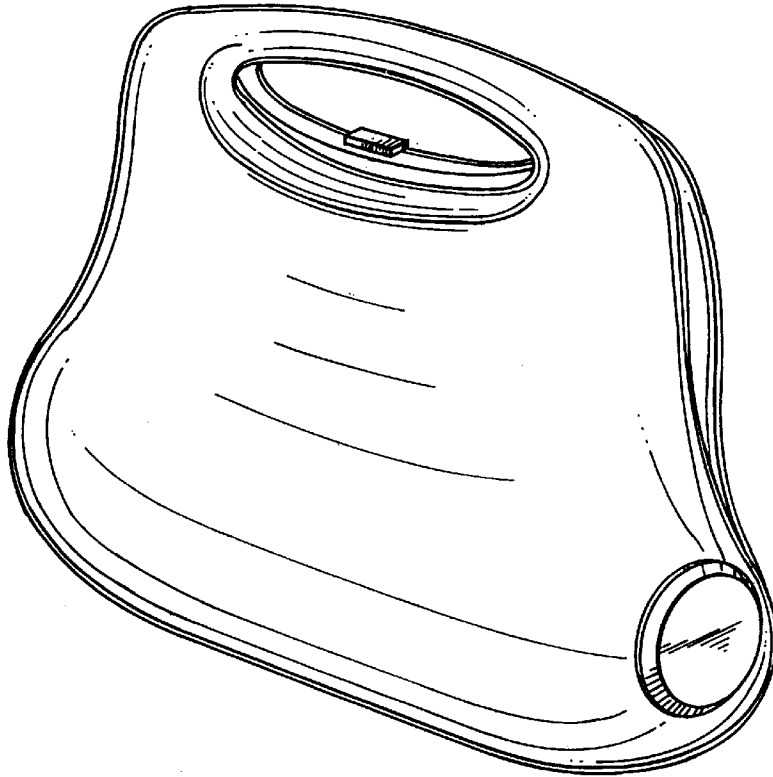

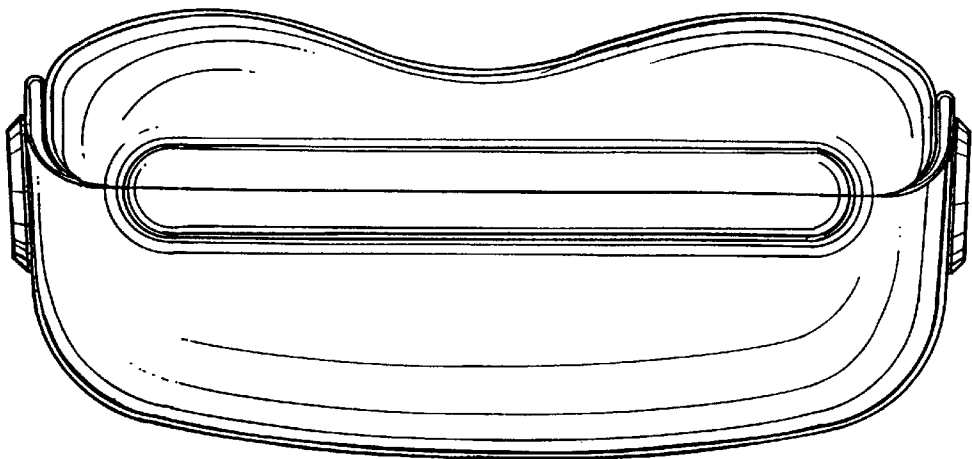

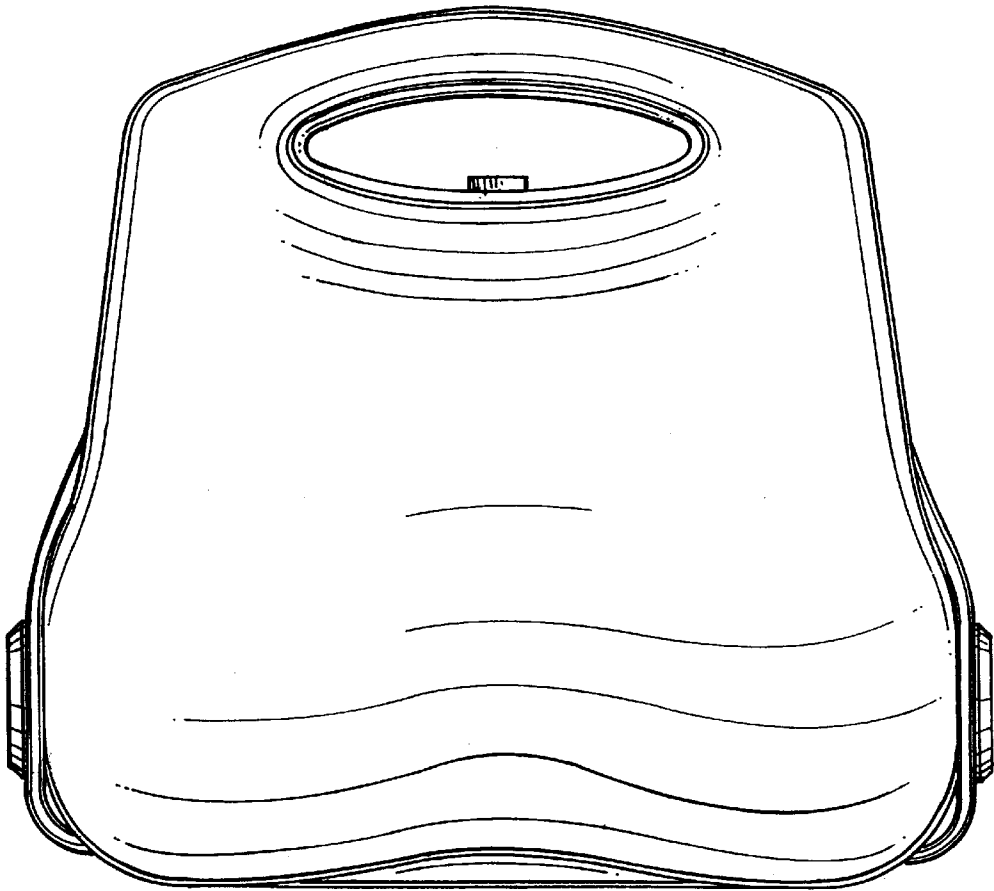

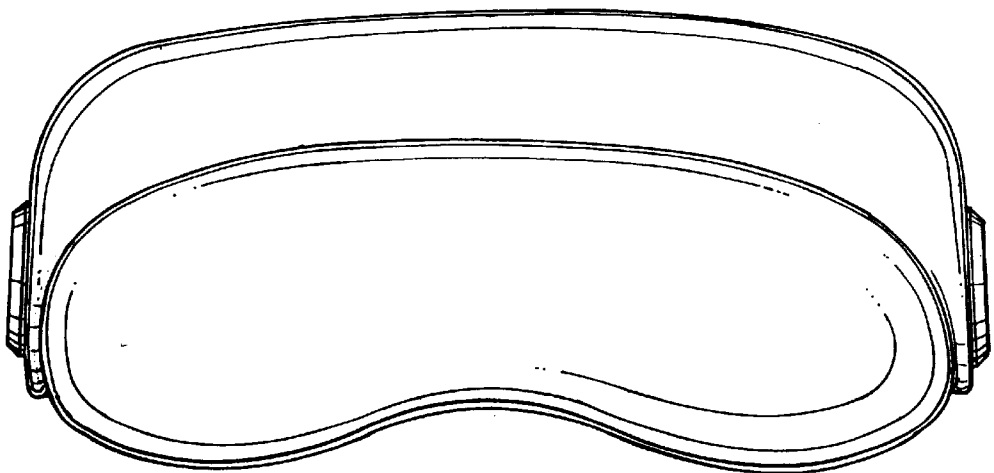

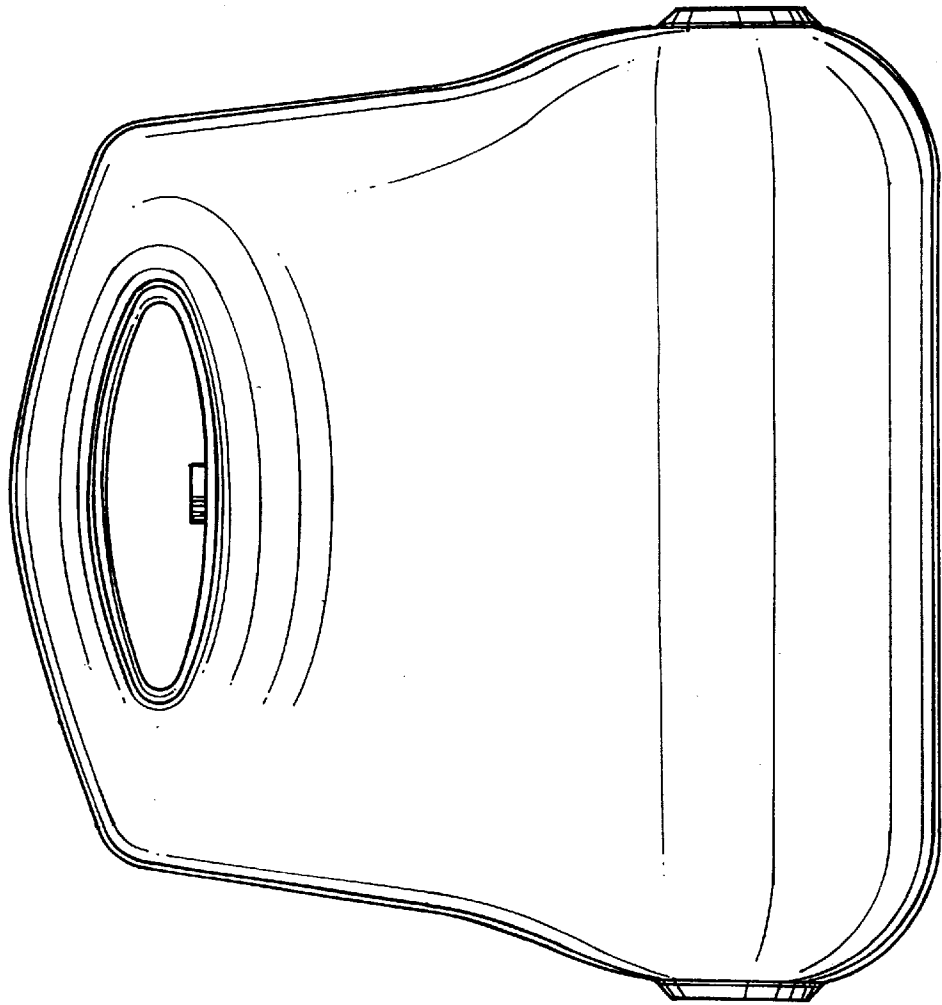
