(57) **CLAIM**


The ornamental design for a handle for laparoscopic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a handle for laparoscopic device in accordance with the present design;  
FIG. 2 is a rear view of the handle for laparoscopic device of FIG. 1;  
FIG. 3 is a front view of the handle for laparoscopic device of FIG. 1;  
FIG. 4 is a top view of the handle for laparoscopic device of FIG. 1;

FIG. 6 is a left side view of the handle for laparoscopic device of FIG. 1; and,












