DESCRIPTION

FIG. 1 is a front elevation view of a motor vehicle, toy and/or replica;

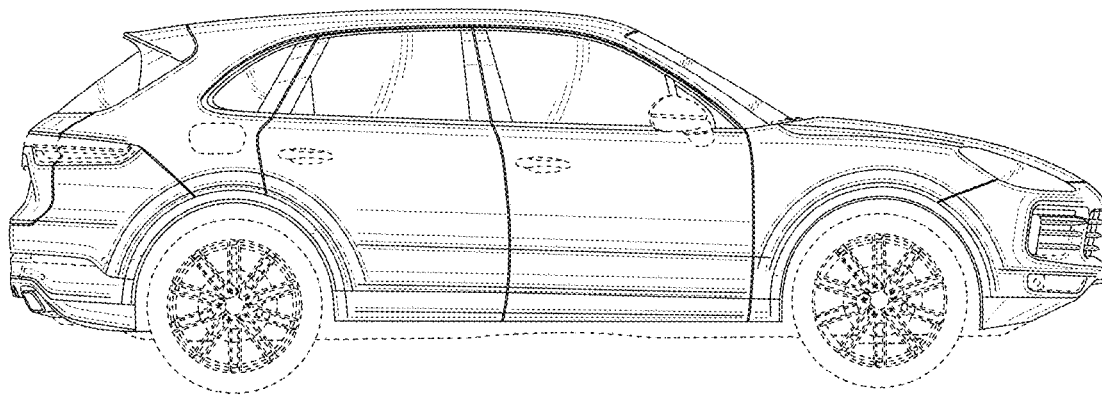
FIG. 2 is a rear elevation view thereof;

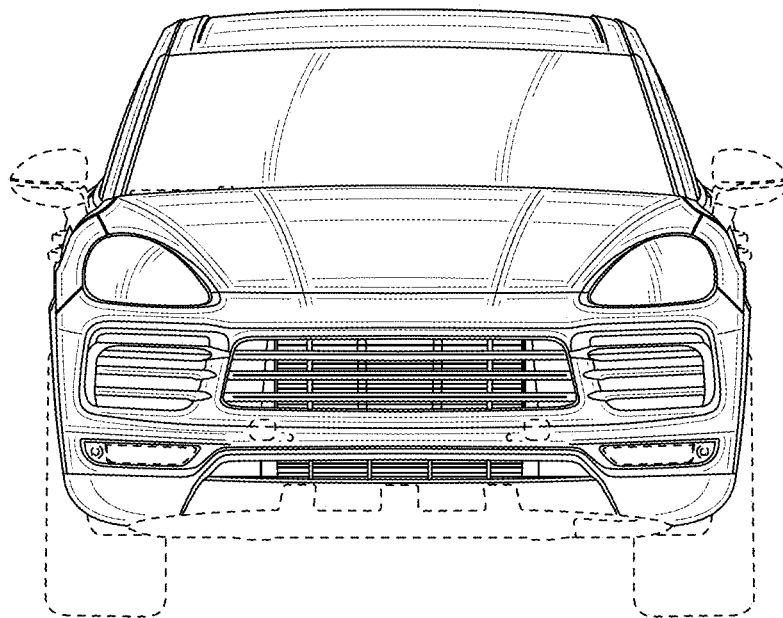

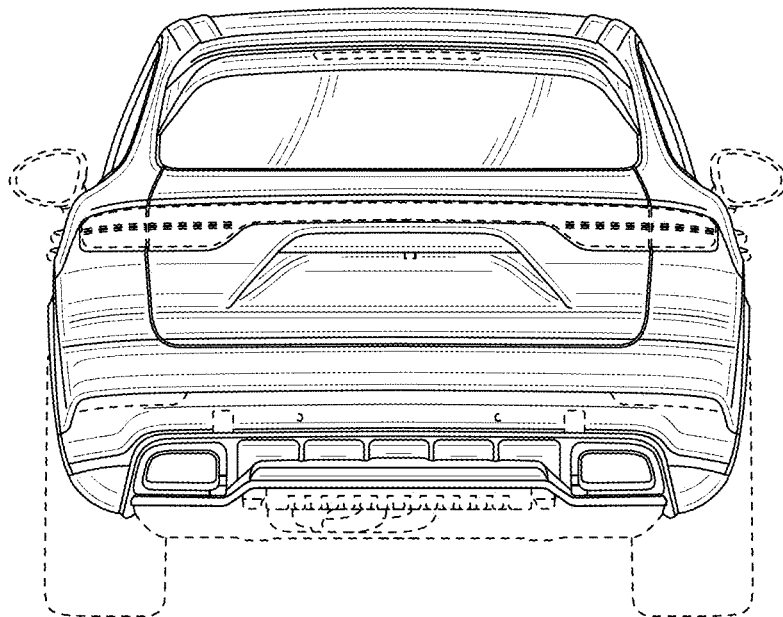

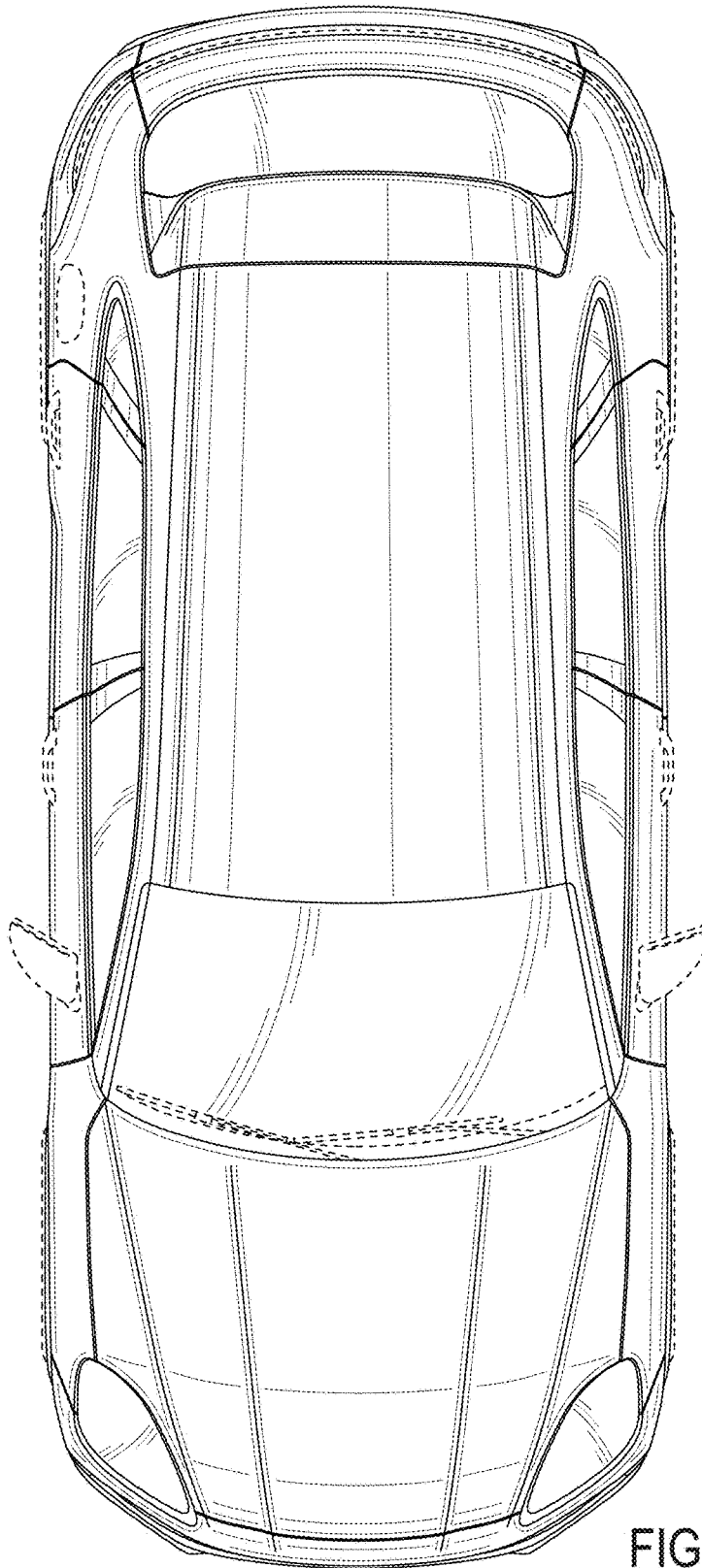

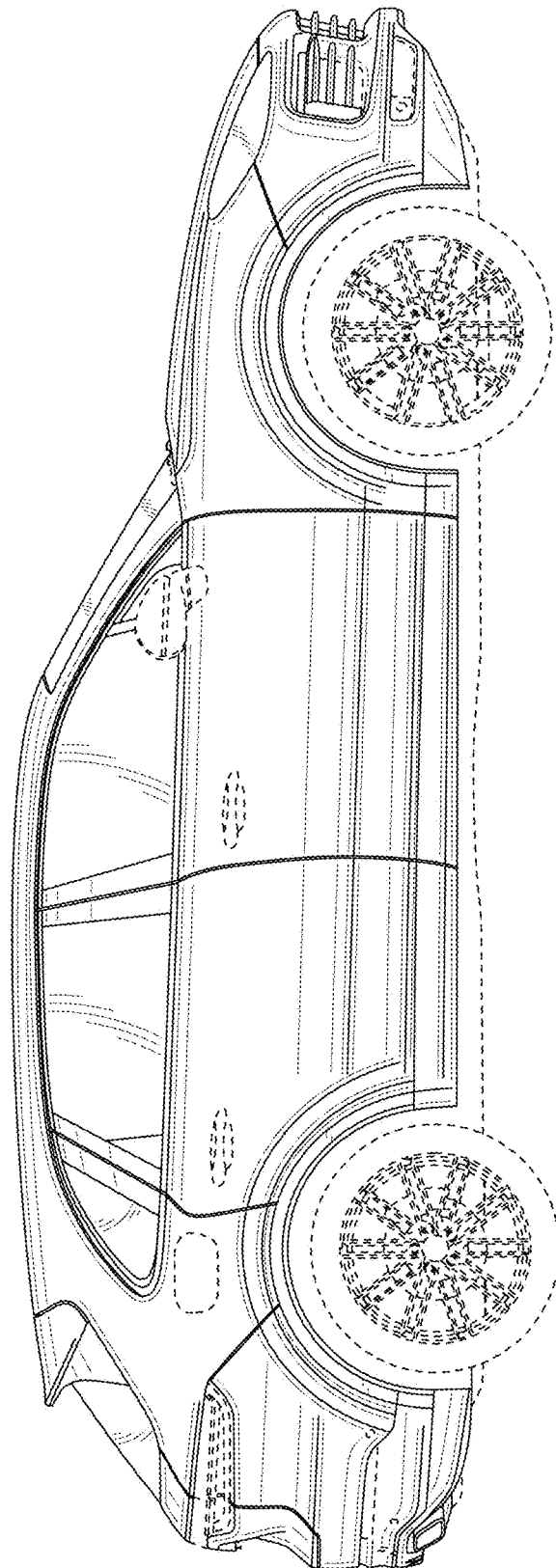
