(57) **CLAIM**

The ornamental design for a water bottle and protective sleeve, as shown and described.

DESCRIPTION

FIG. 11 is a left side view of FIG. 7;

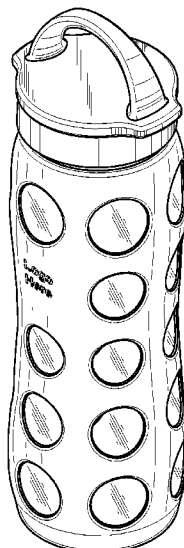
FIG. 12 is a rear view of FIG. 7;

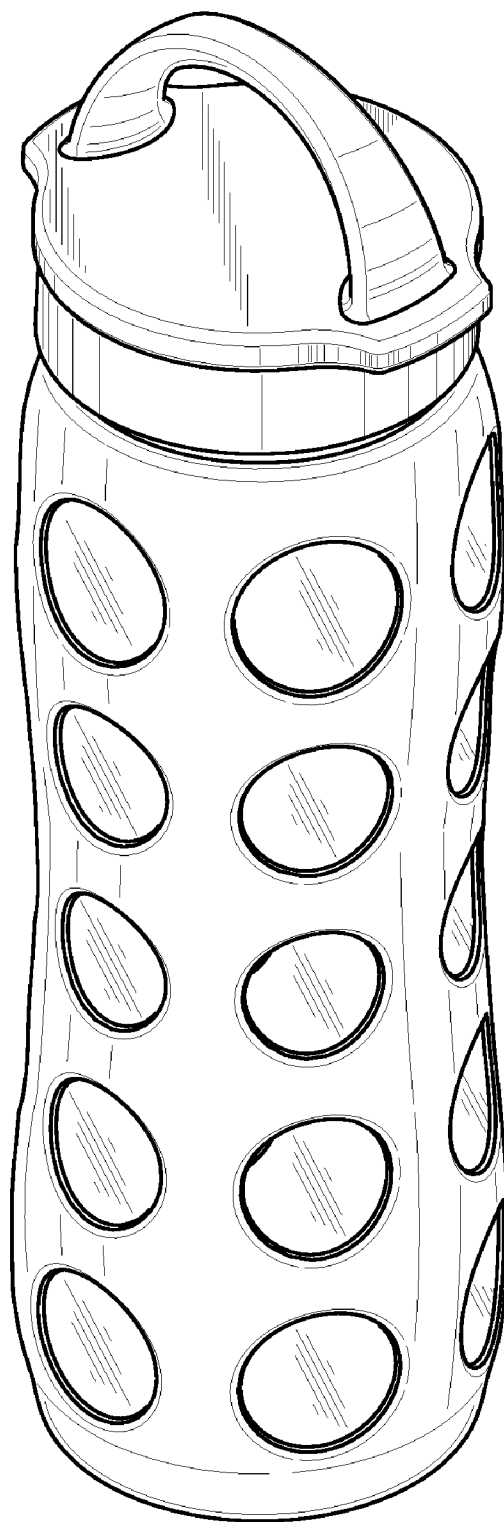

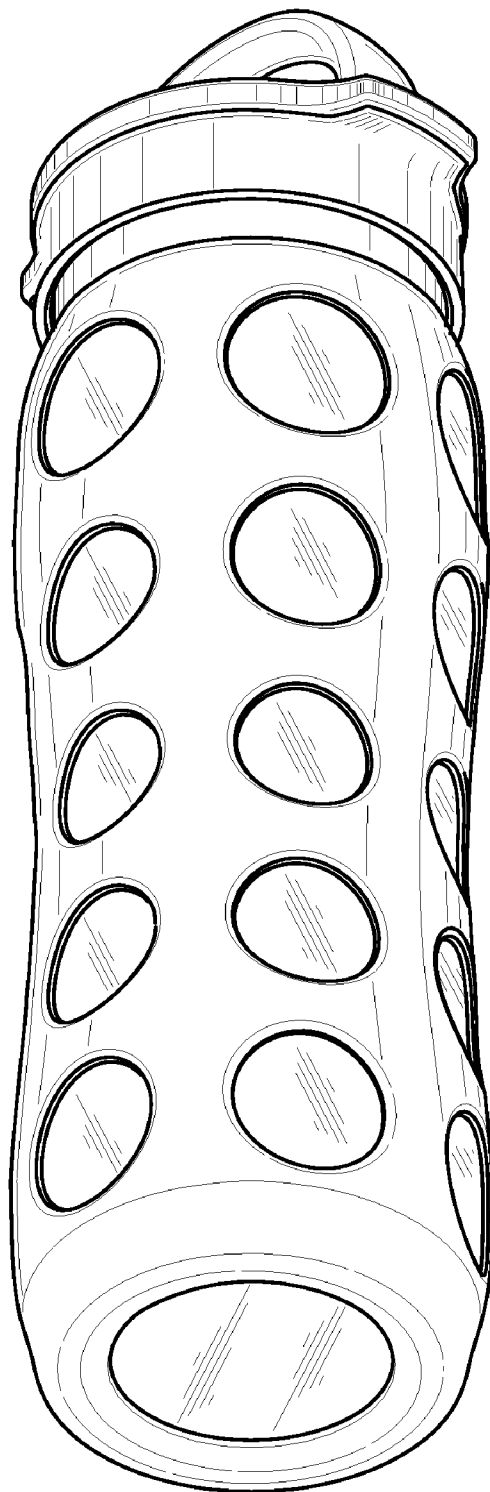

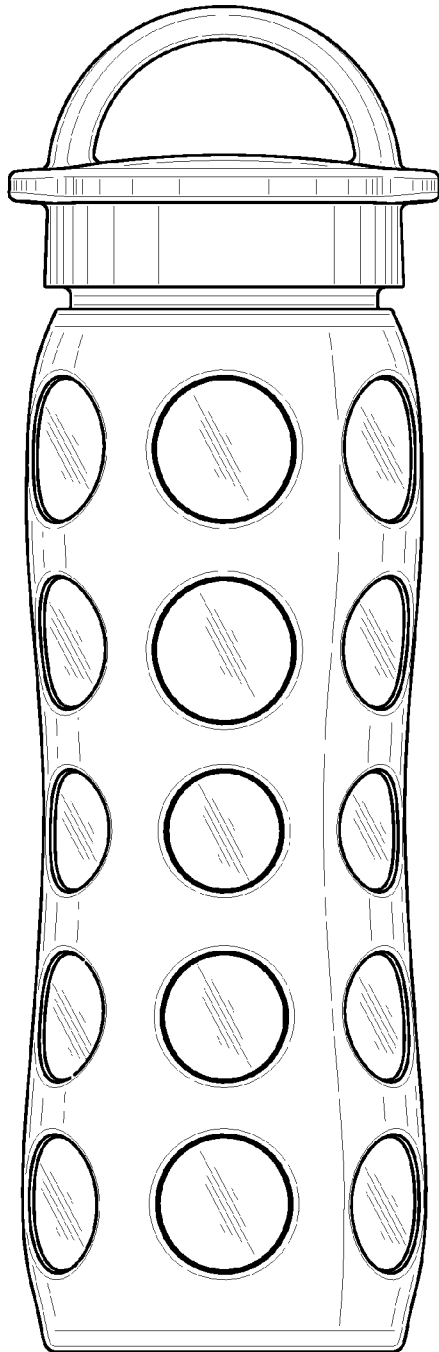

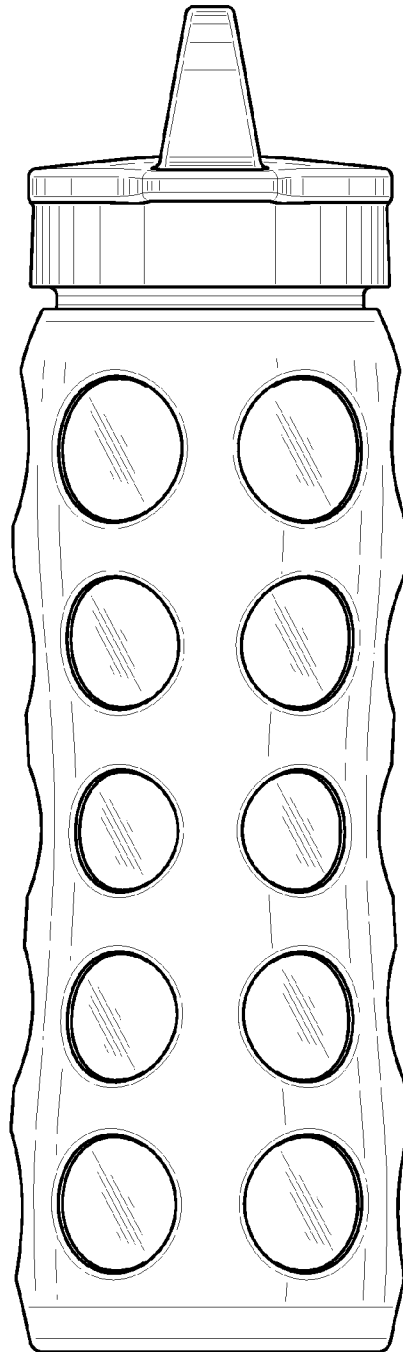

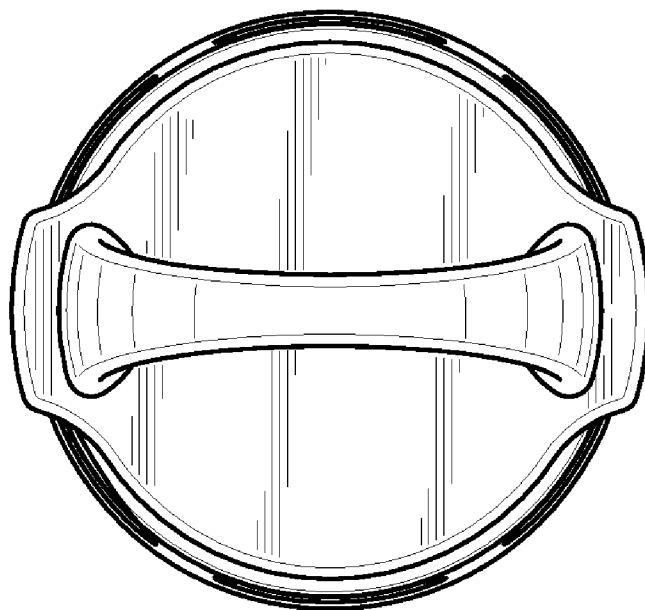

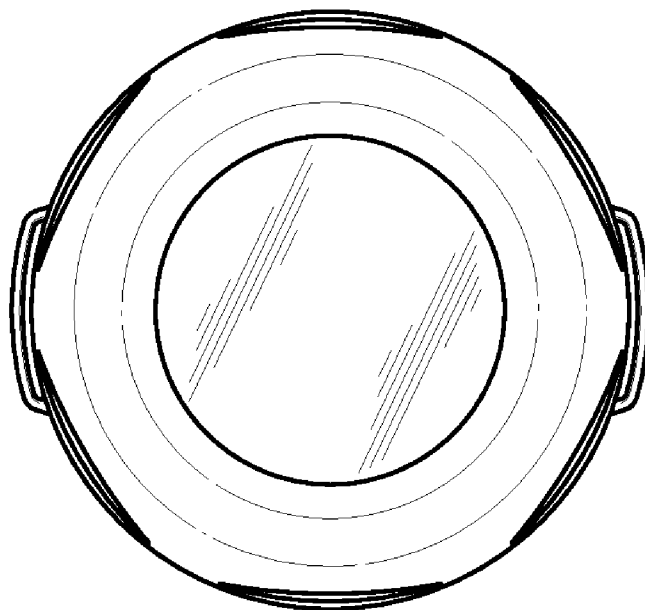

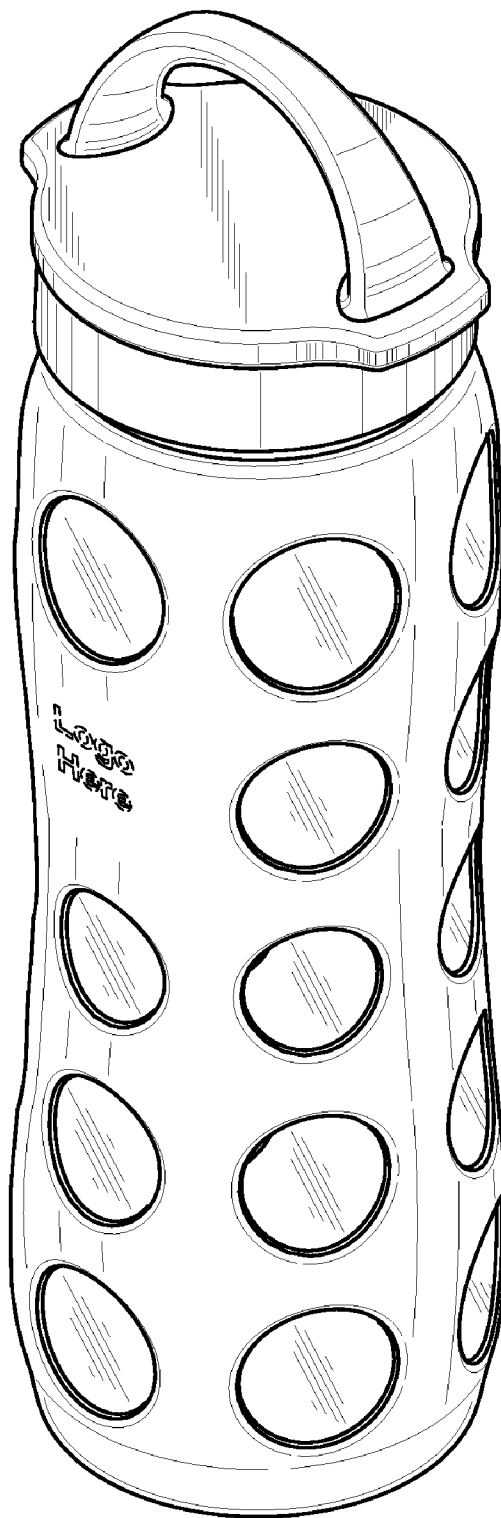

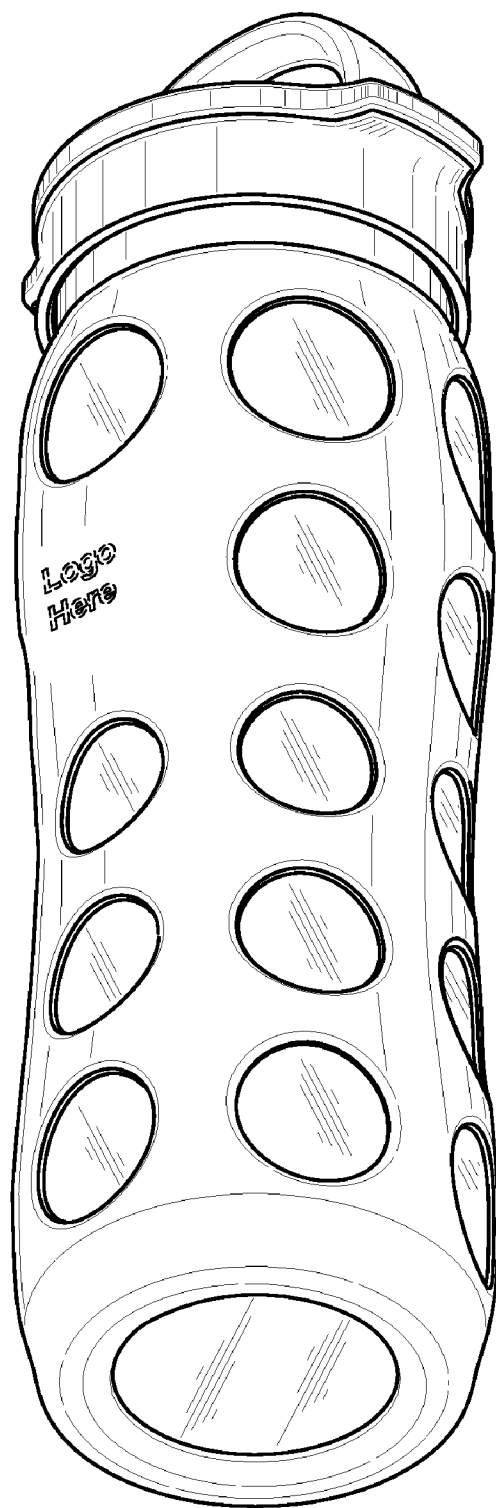

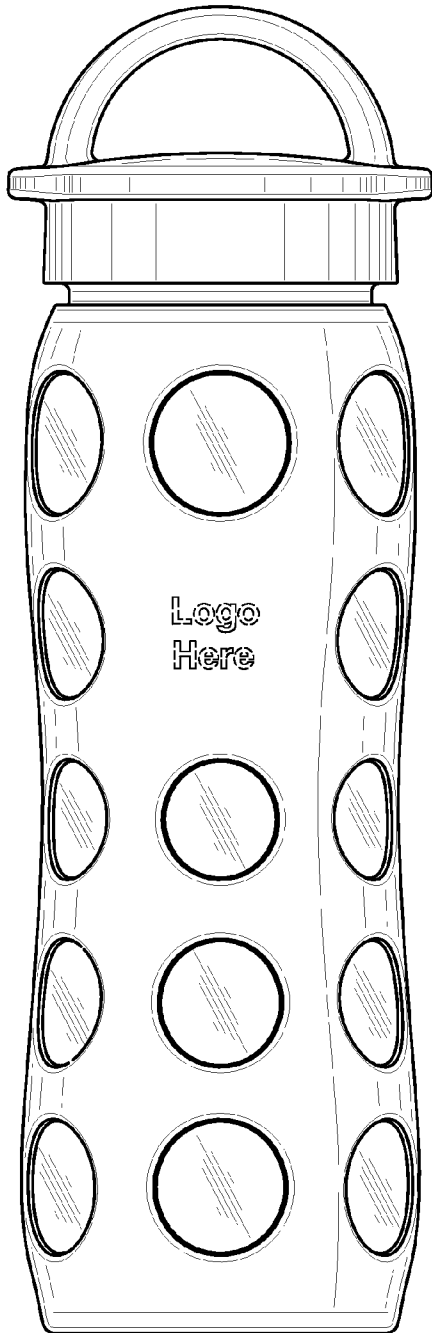

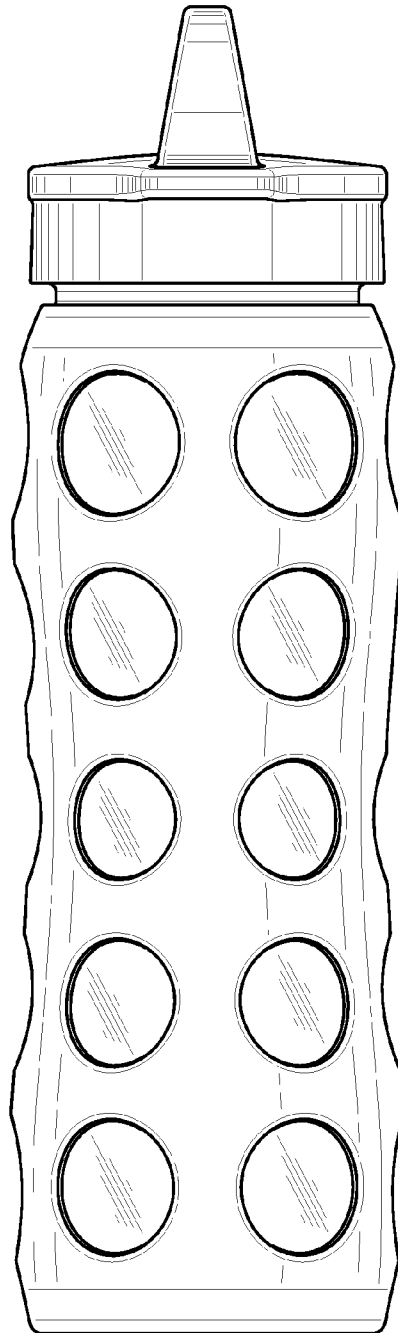

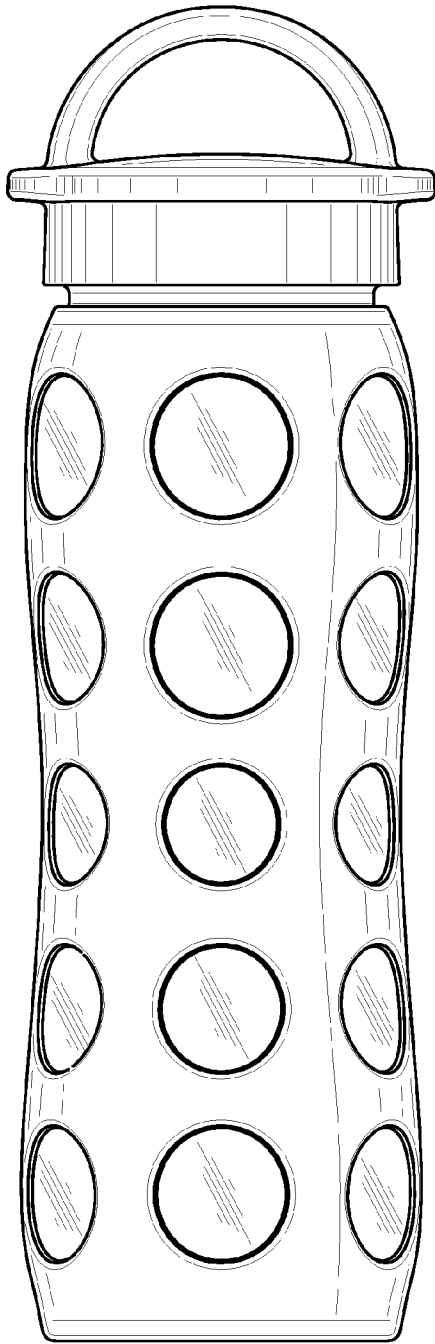

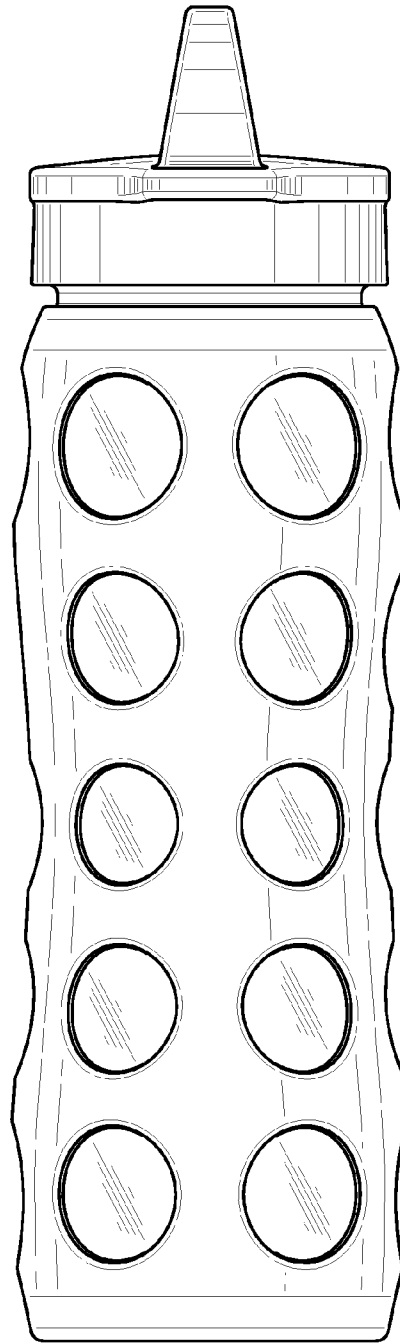

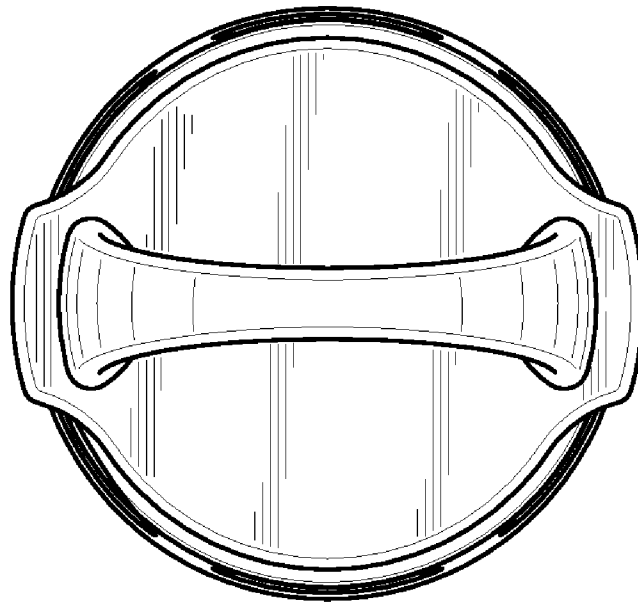

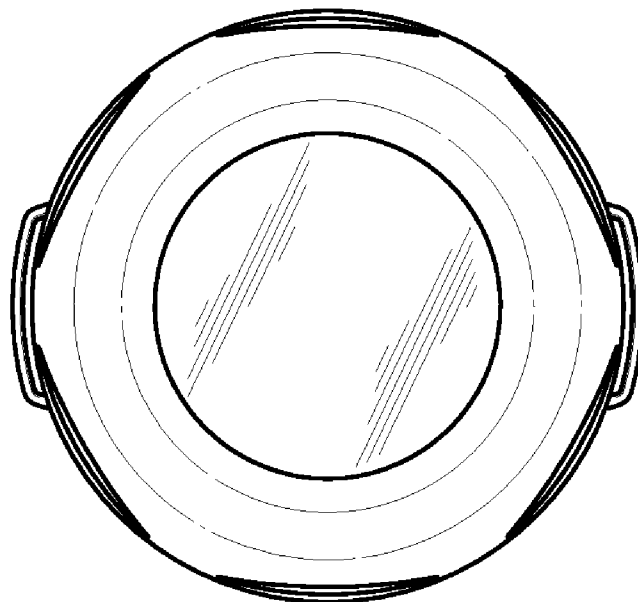
