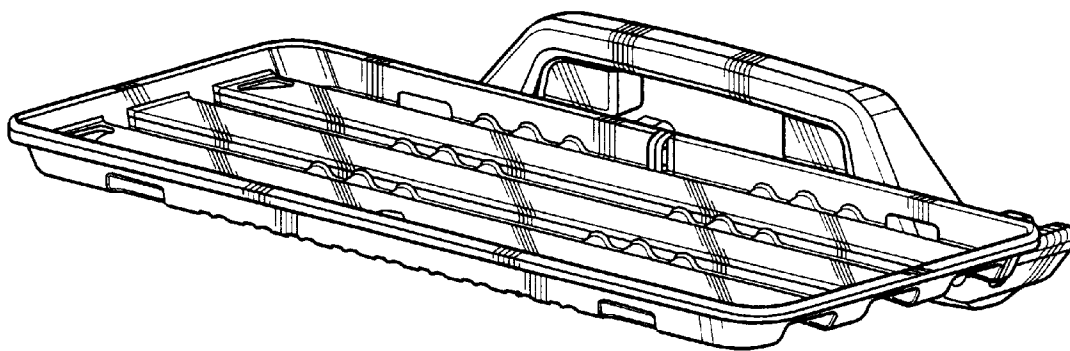
[57] CLAIM

The ornamental design for hitch mount cargo carrier and hitch cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hitch mount cargo carrier and hitch cover showing our new design;
FIG. 2 is an enlarged top plan view thereof;
FIG. 3 is an enlarged rear elevational view thereof;
FIG. 4 is an enlarged bottom plan view thereof;
FIG. 5 is an enlarged left side elevational view thereof, the right side being a mirror image of the left shown; and,
FIG. 6 is an enlarged front elevational view thereof.

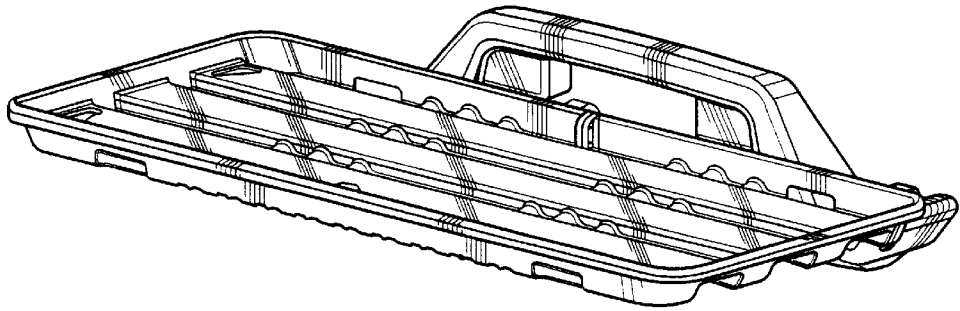

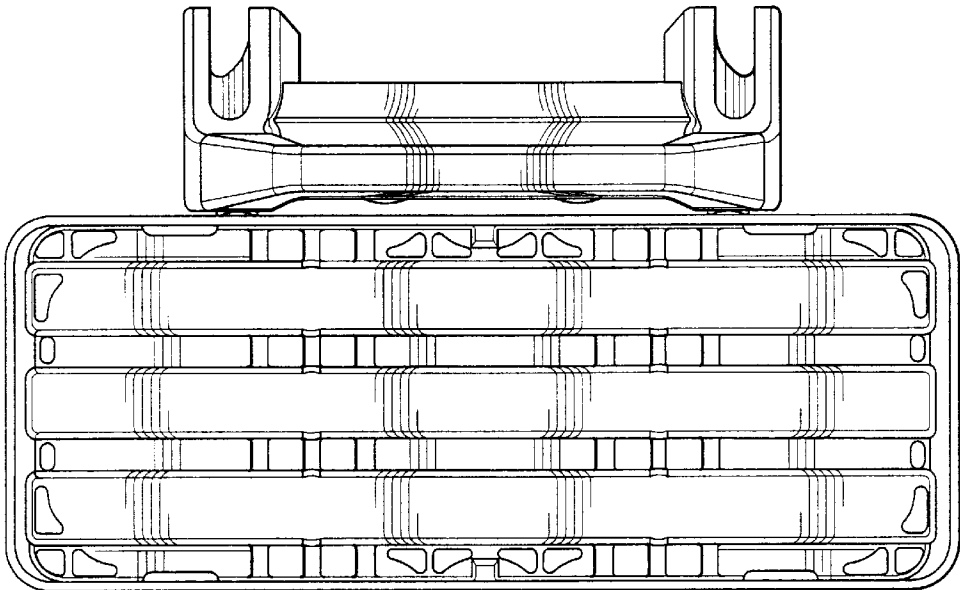

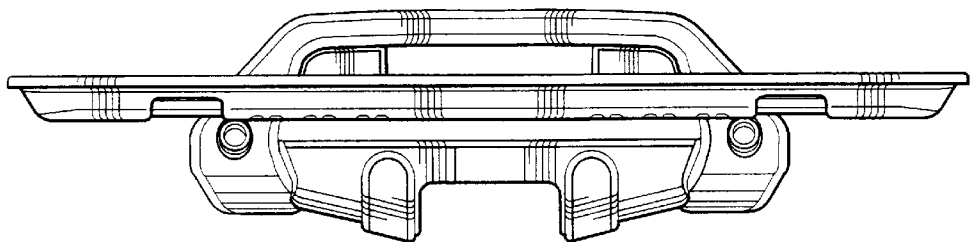

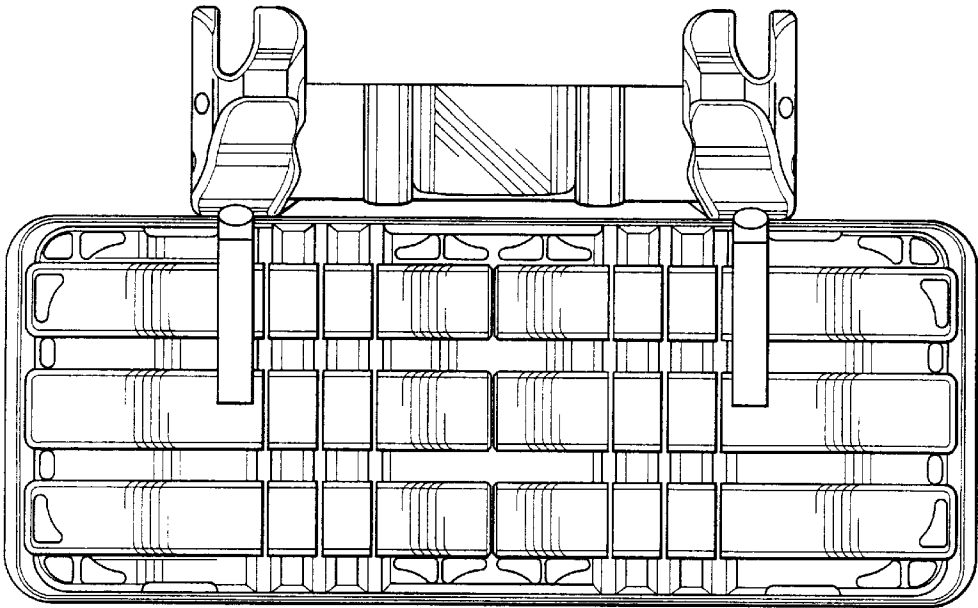

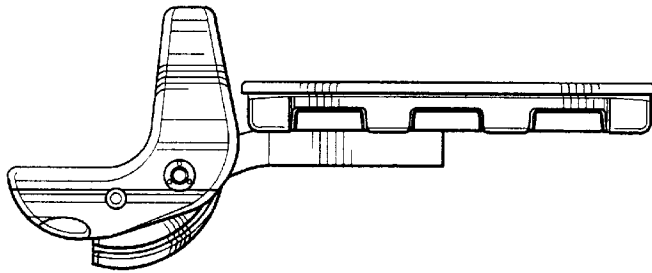

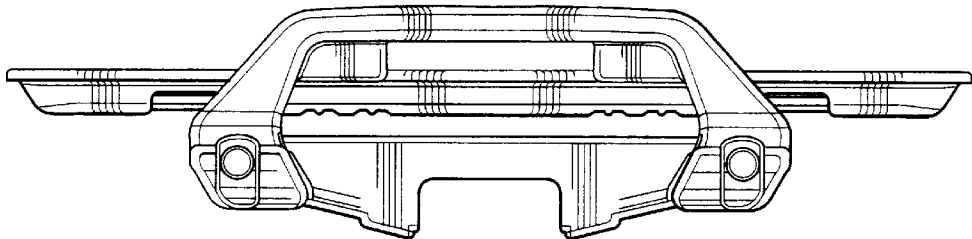
