(57) **CLAIM**

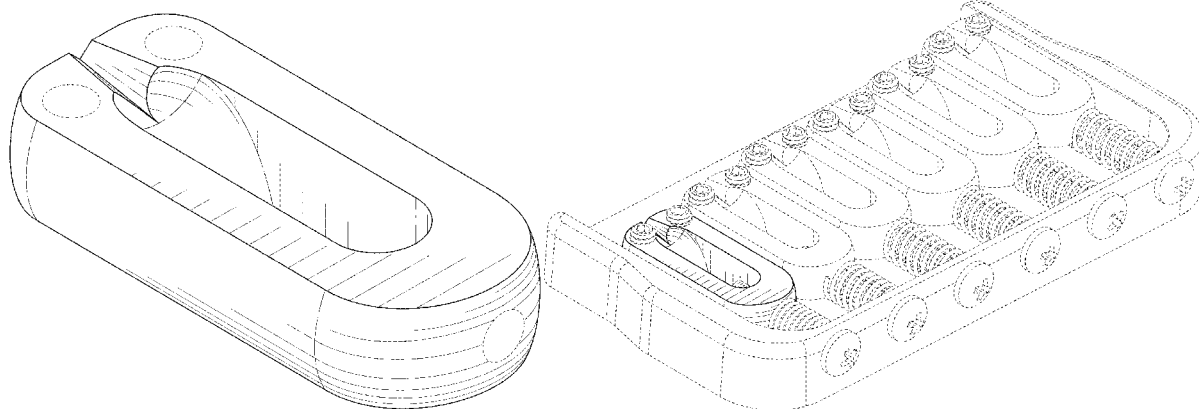
The ornamental design for a bridge saddle for electric guitar, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bridge saddle for electric guitar, showing our new design; FIG. 2 is a right side view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a cross-sectional view thereof taken along line 8-8 of FIG. 6; and, FIG. 9 is a perspective view thereof as applied to an electric guitar bridge.

The broken lines are included for the purpose of illustrating environment only and form no part of the claimed design.

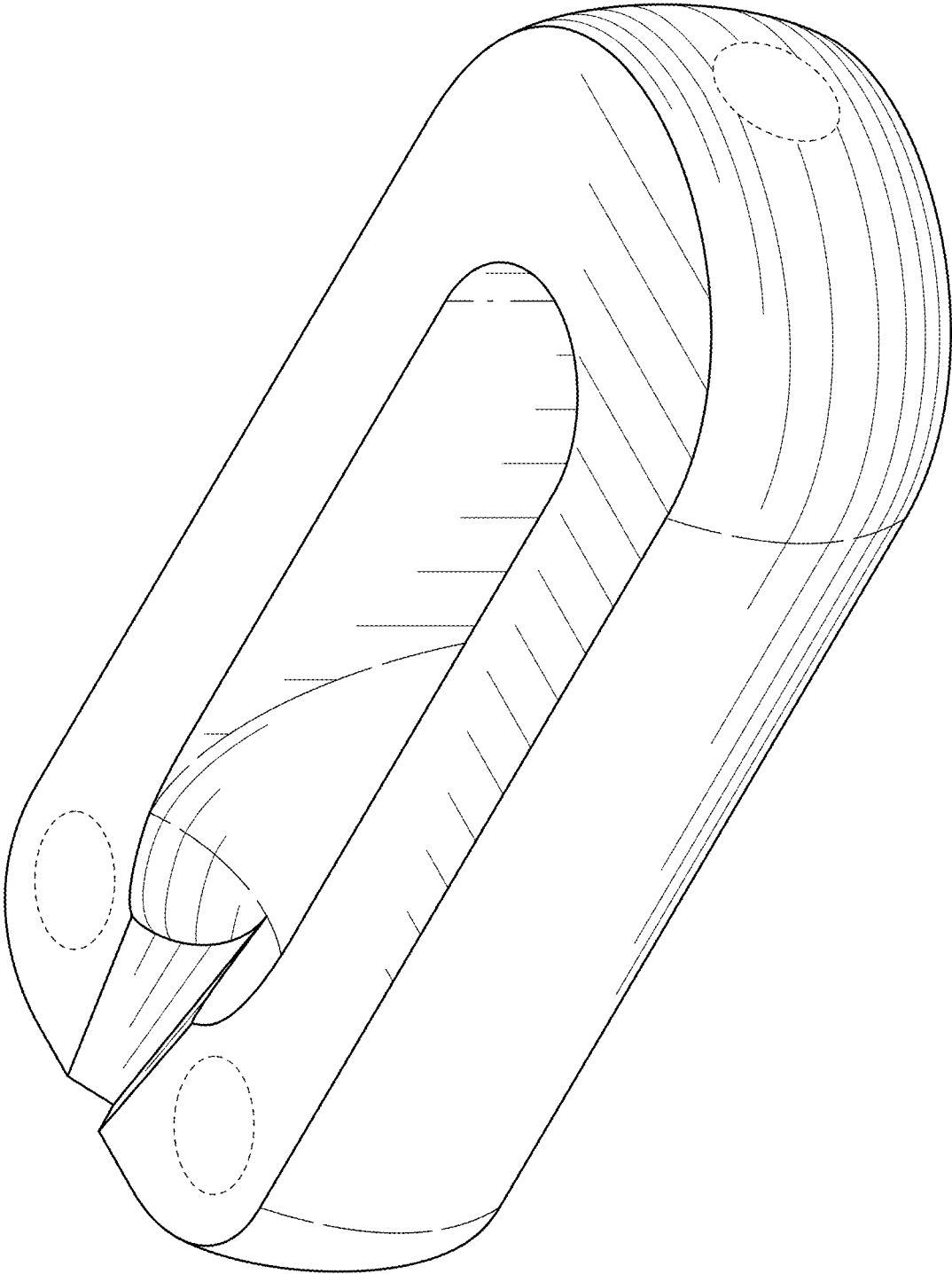

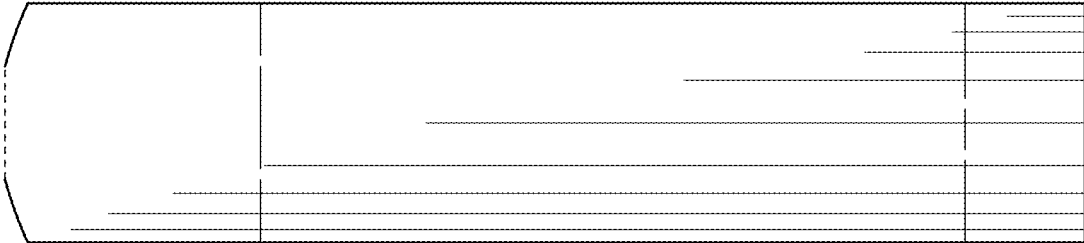

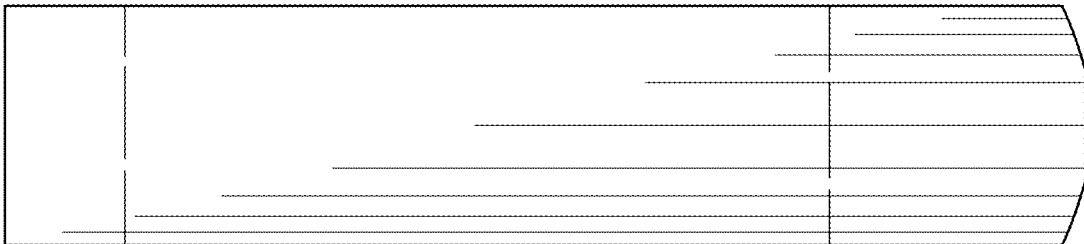

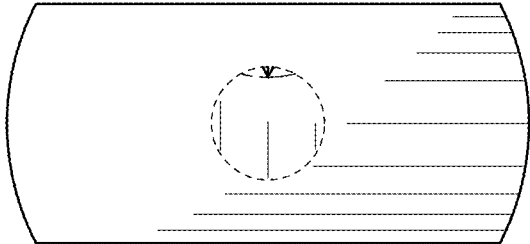

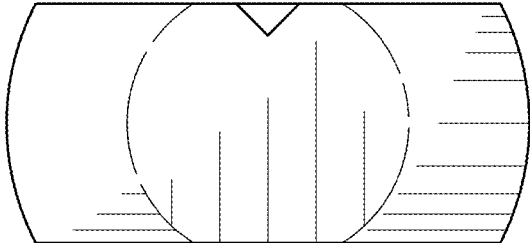

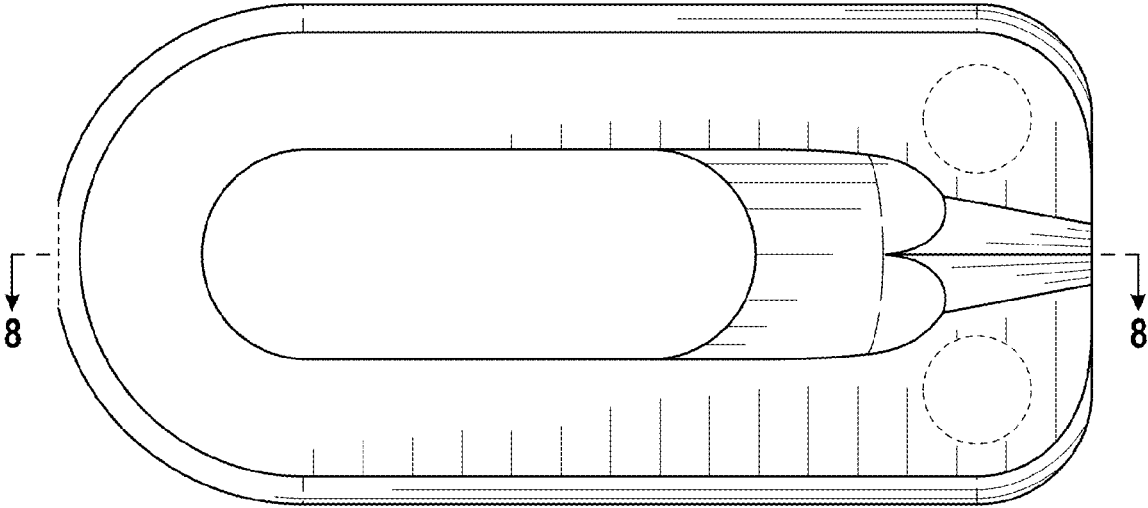

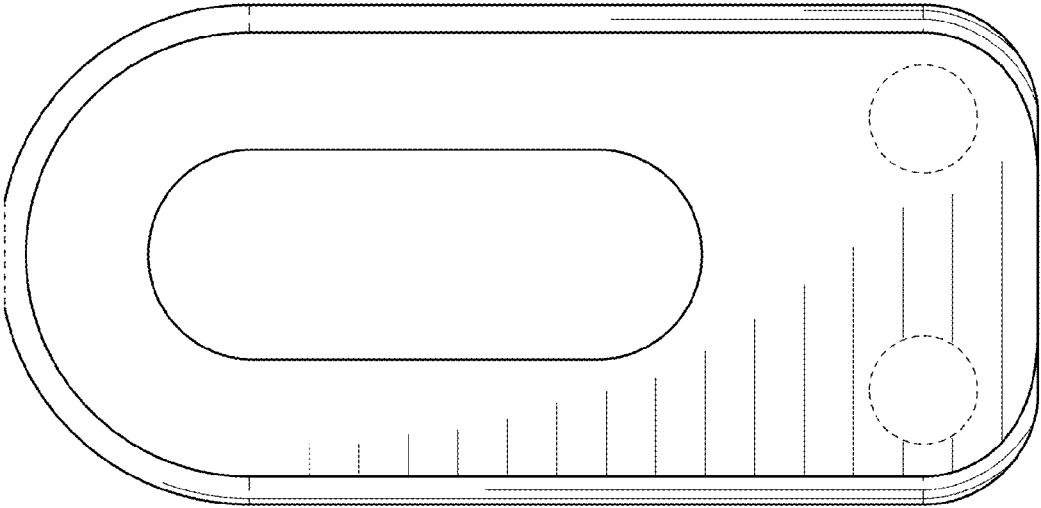

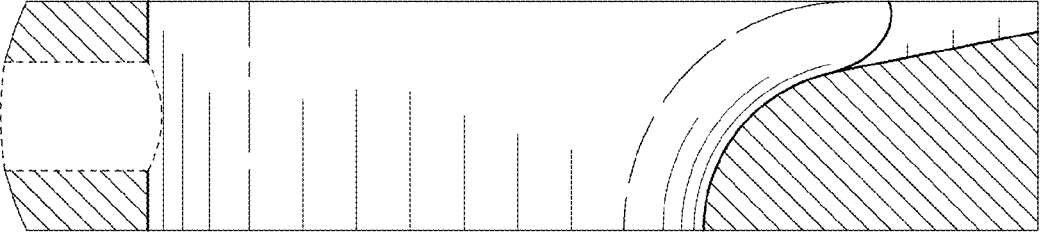

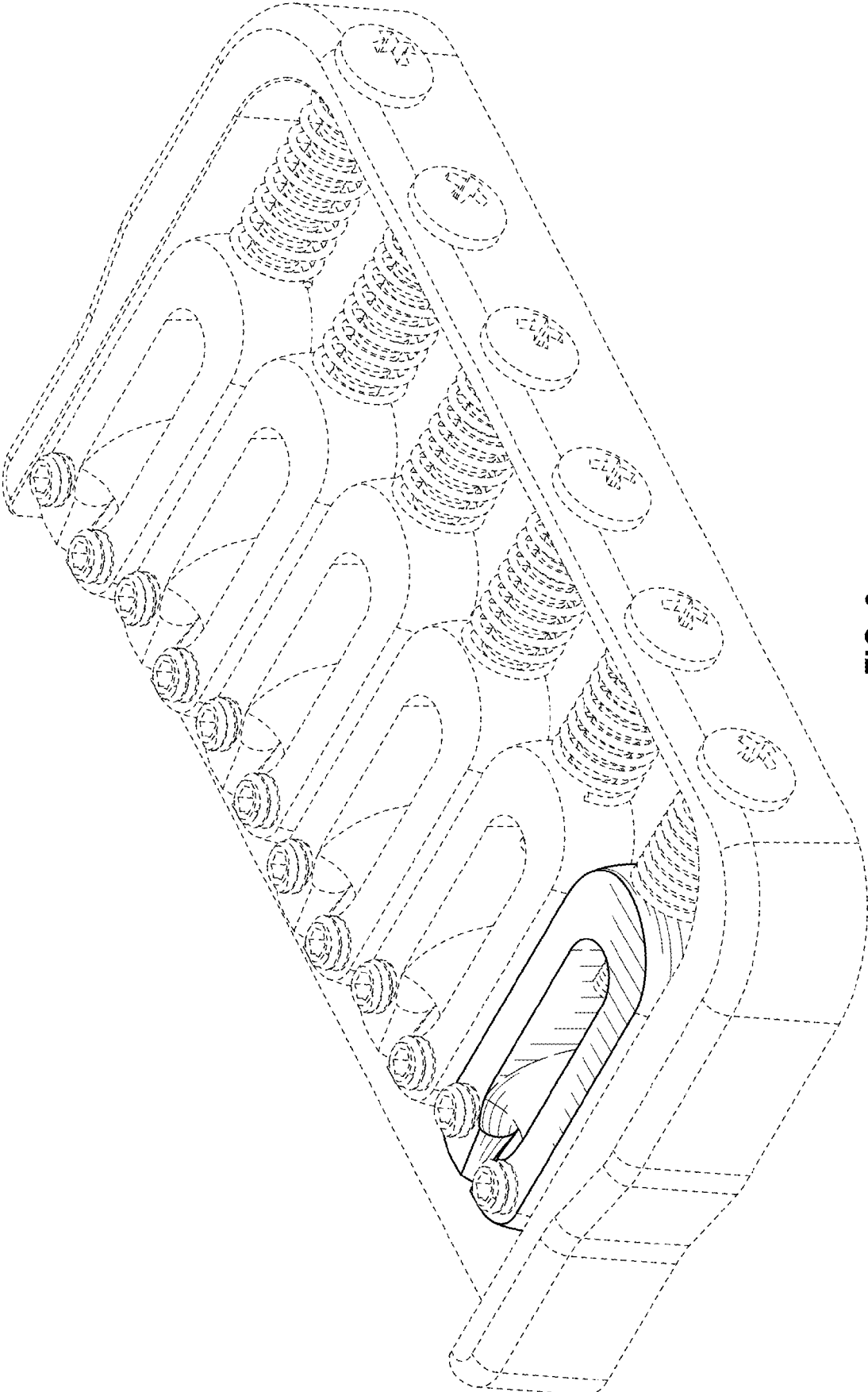
