**DESCRIPTION**

FIG. 14 is a right side elevation view thereof.

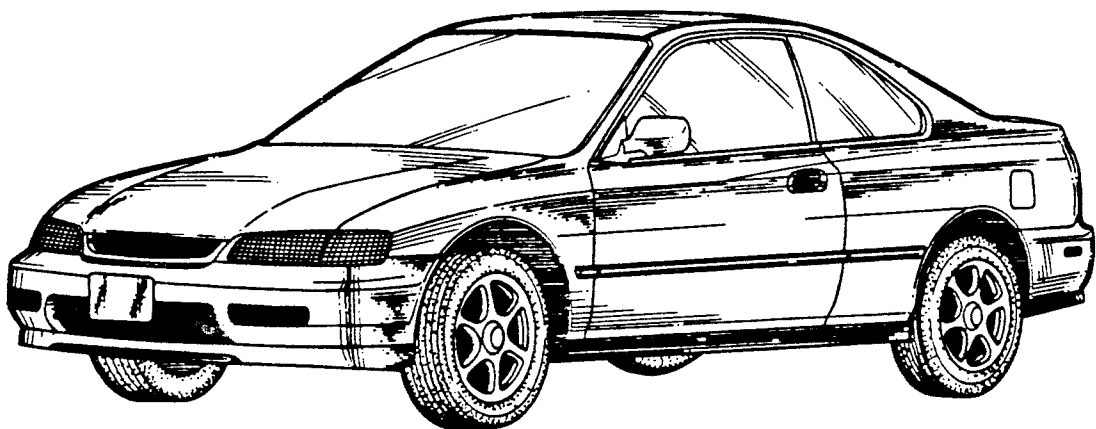

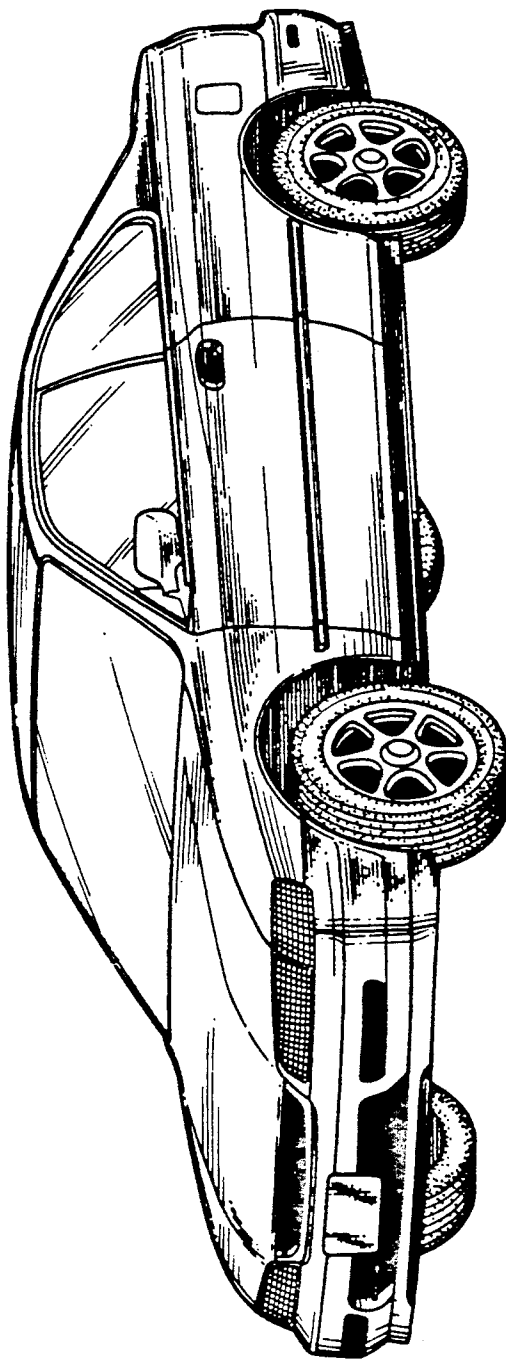

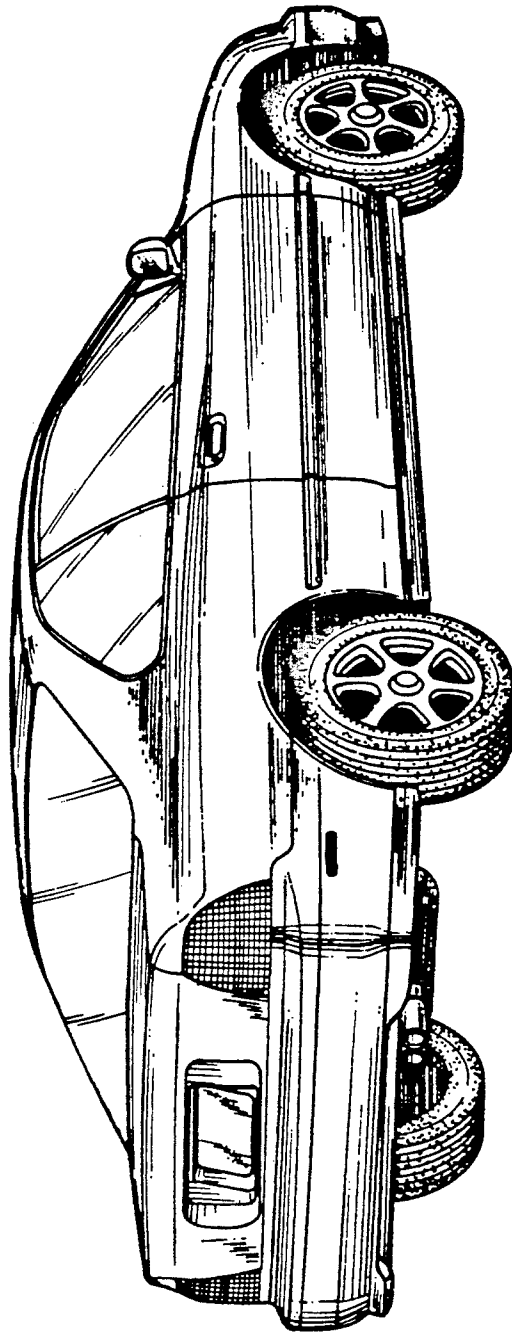

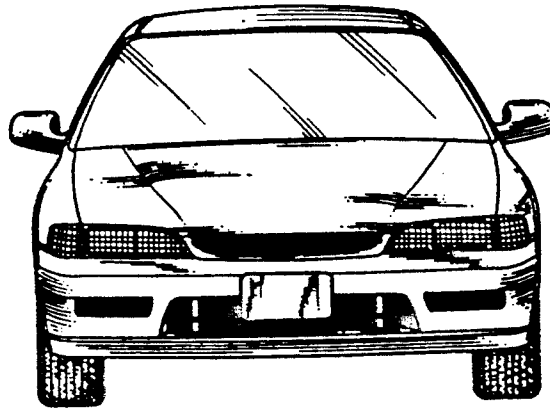

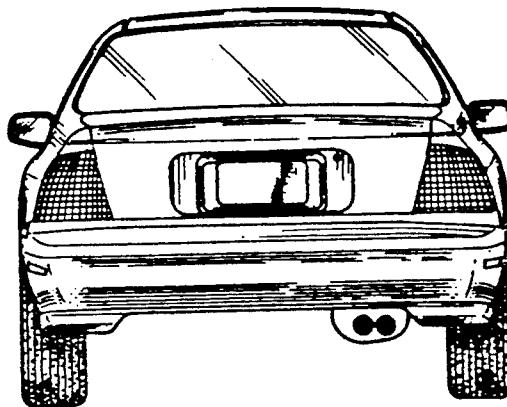

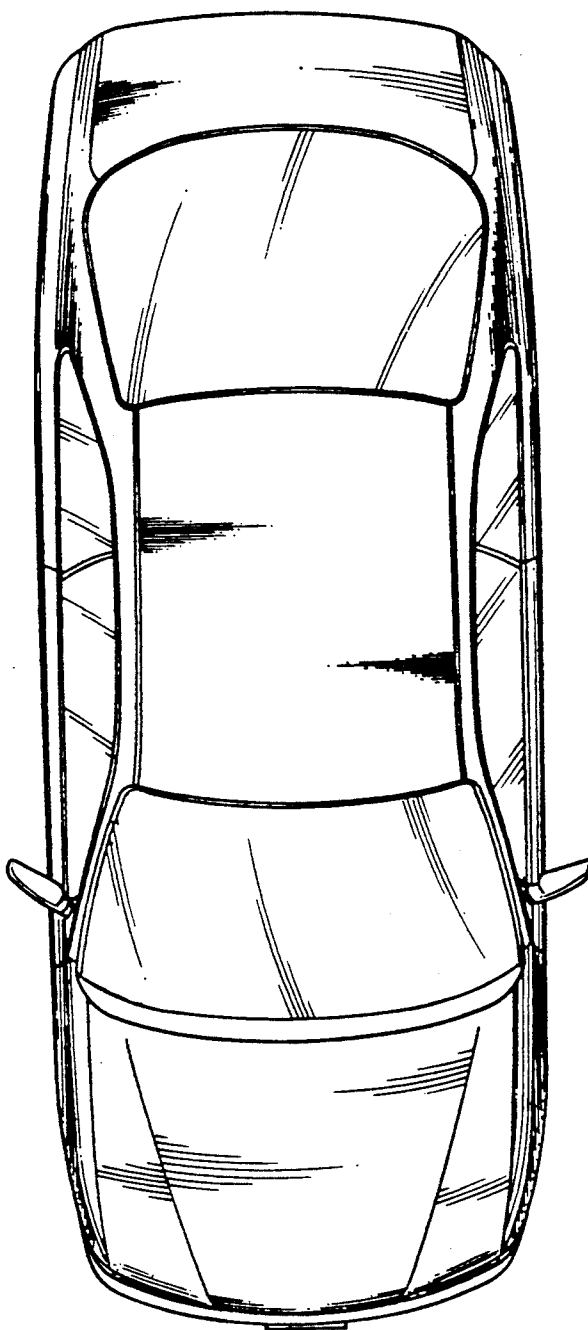

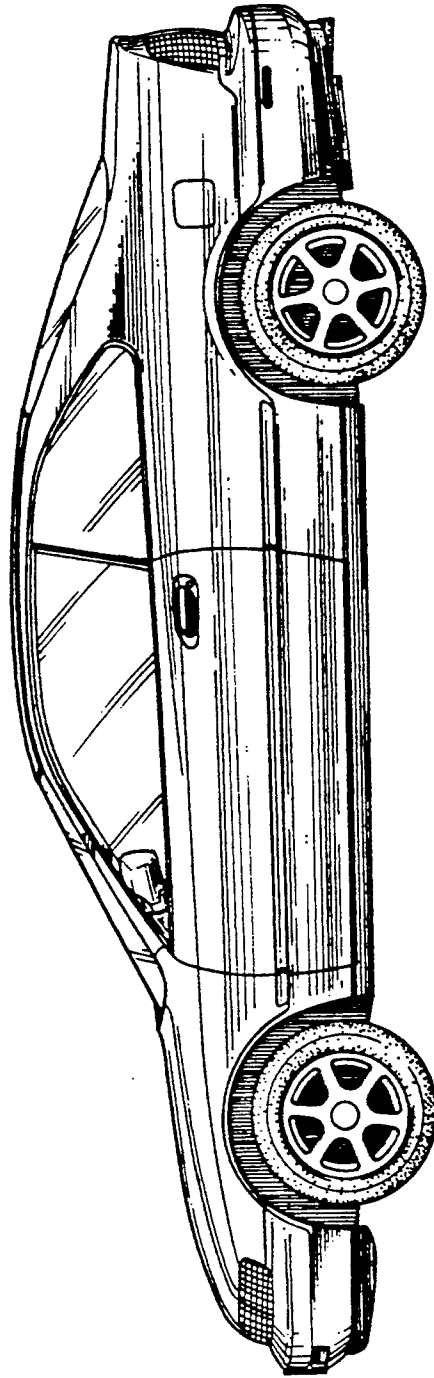

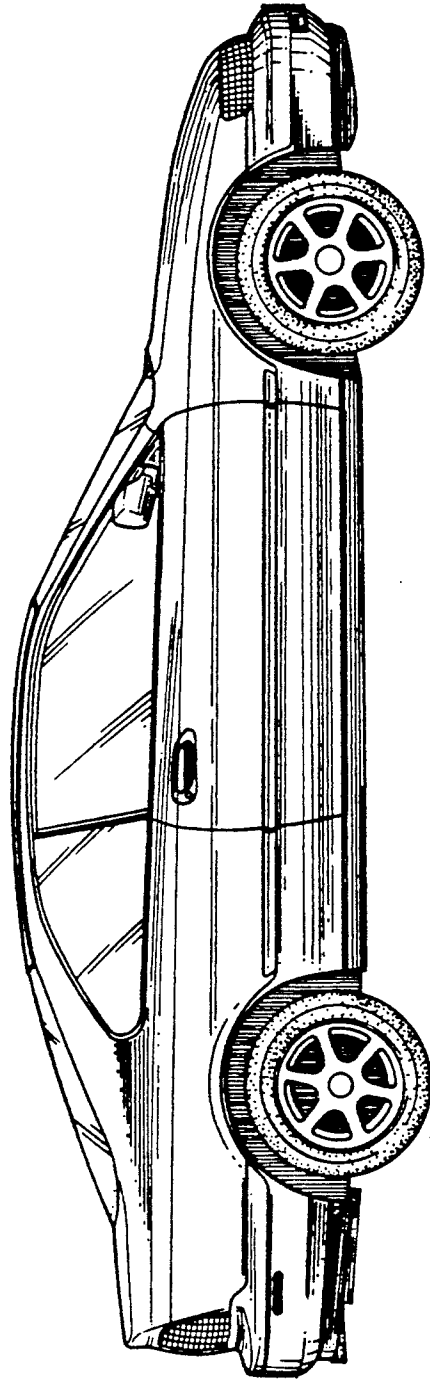

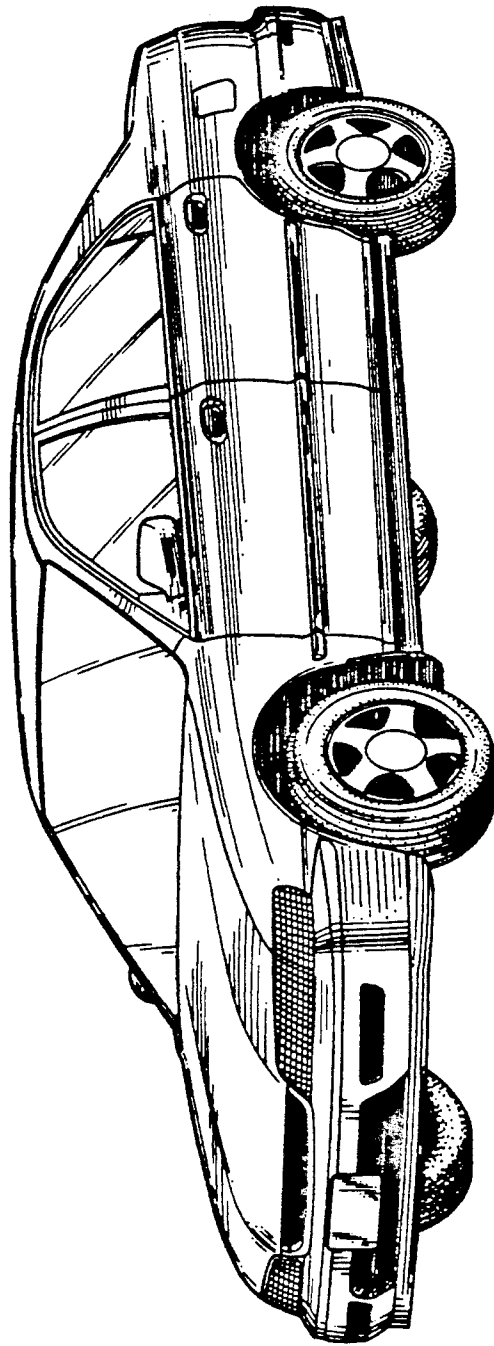

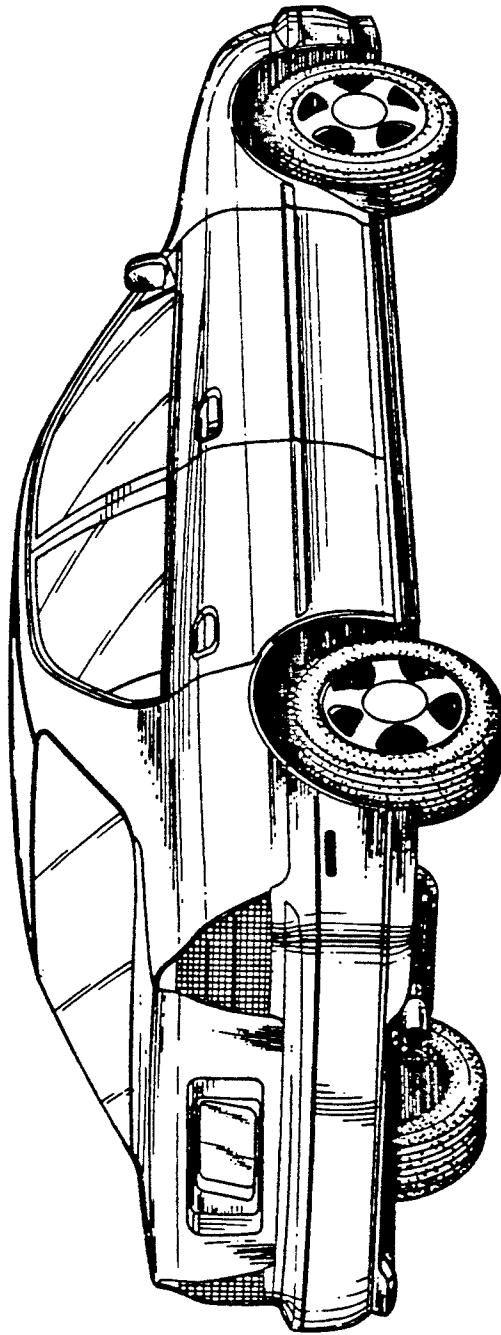

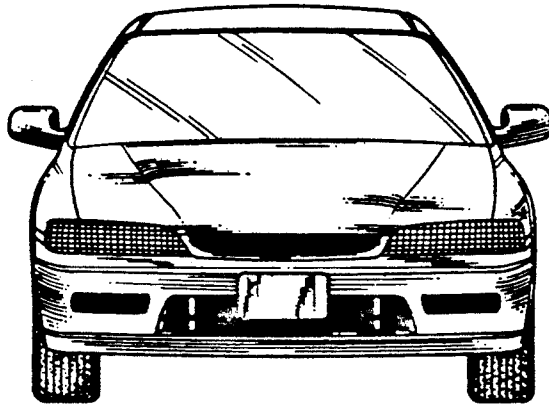

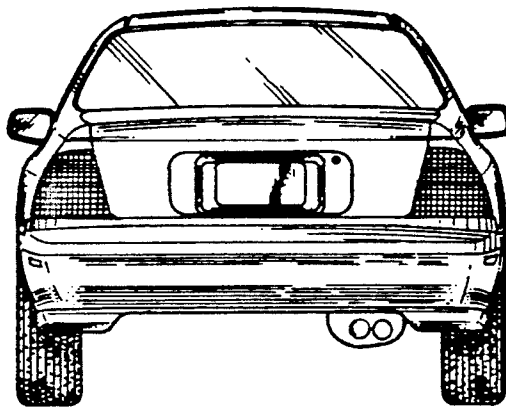

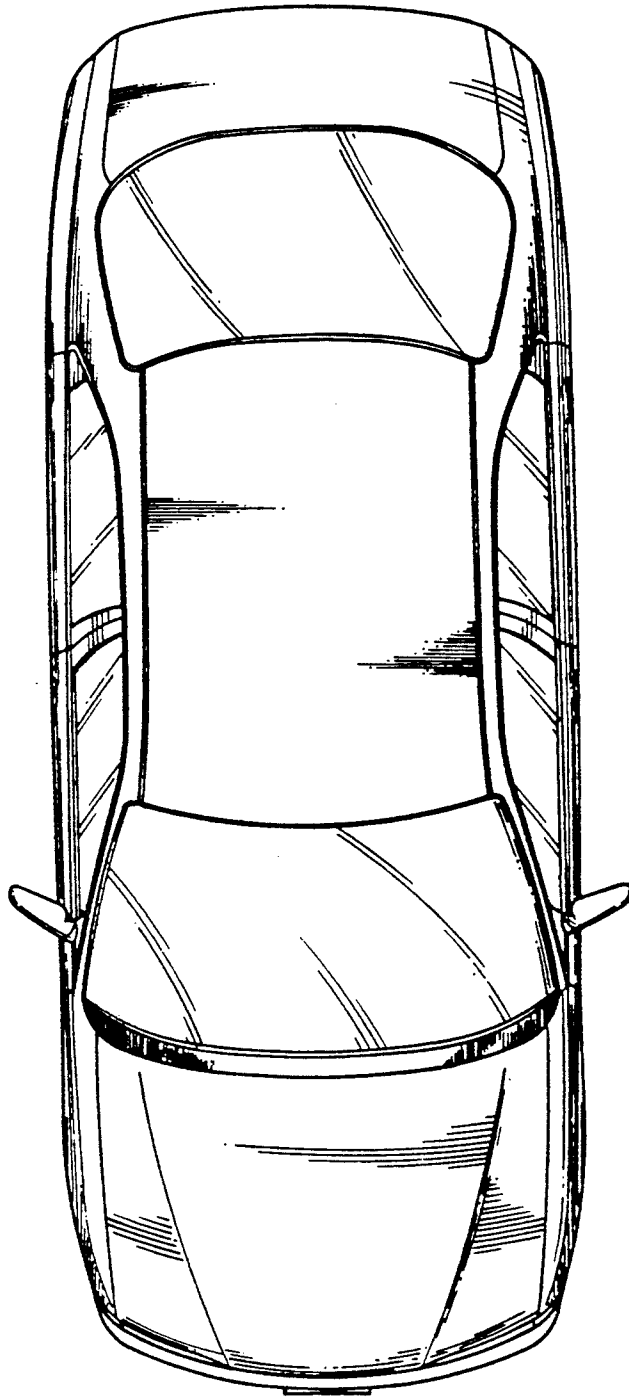

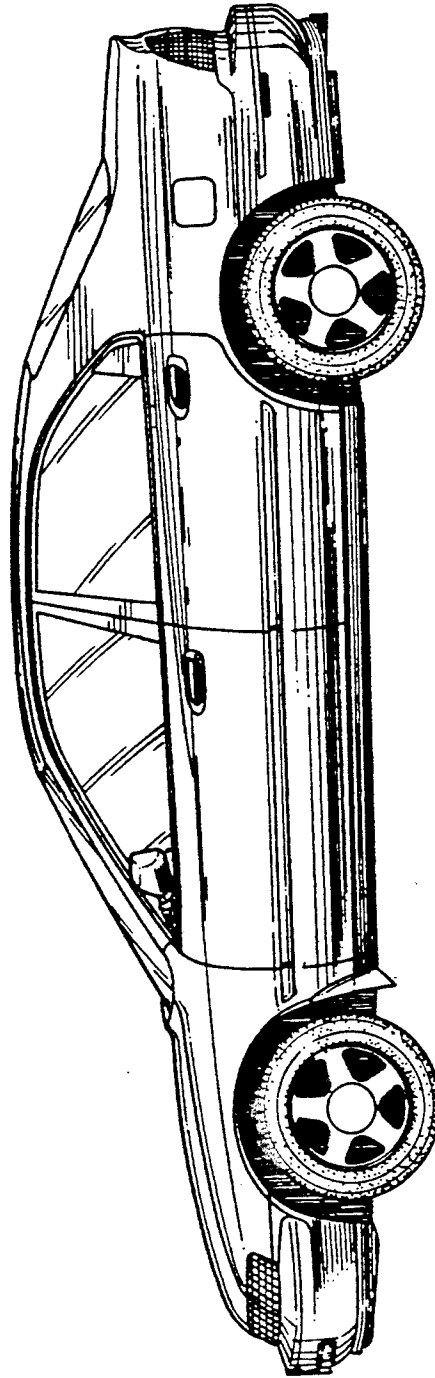
