FIG. 1 is a front perspective view of an exercise bicycle showing our new design;

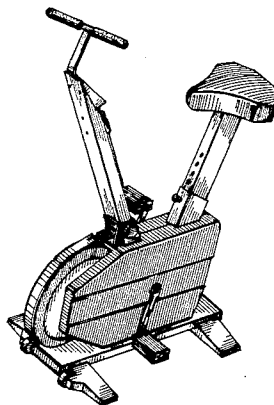
FIG. 2 is a rear perspective view thereof;

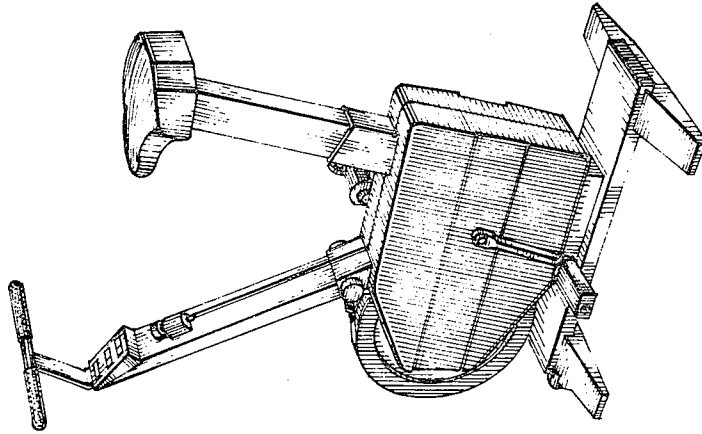
FIG. 3 is a side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

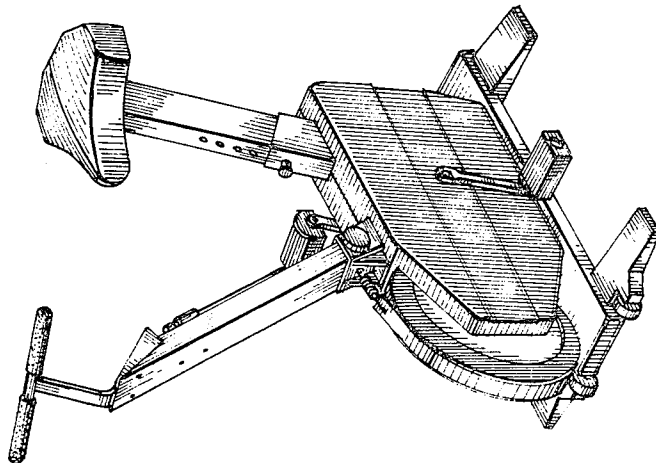
FIG. 5 is a front elevational view thereof; and,

FIG. 6 is a top plan view thereof.

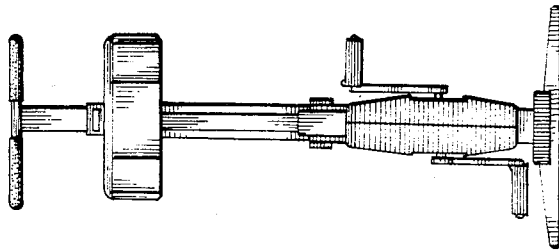




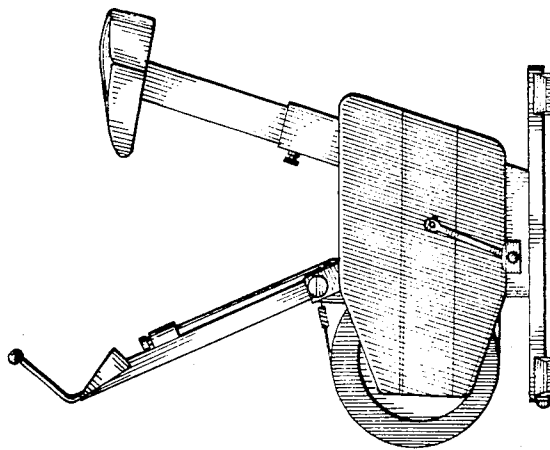

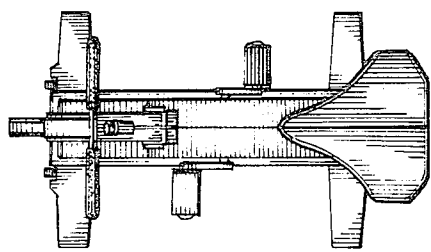

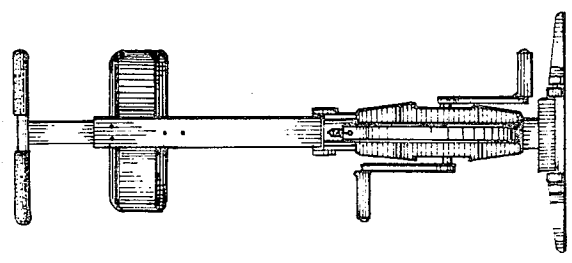

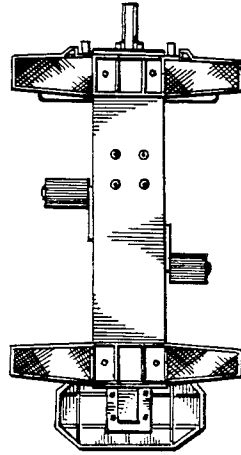
