(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 4 is a front view of a second embodiment of a display screen or portion thereof with animated graphical user interface showing a first image of the claimed design;

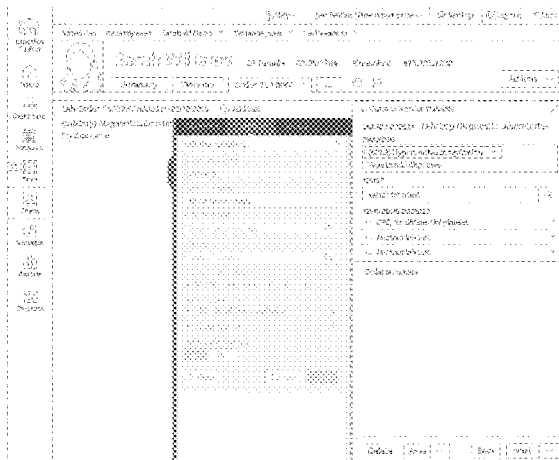
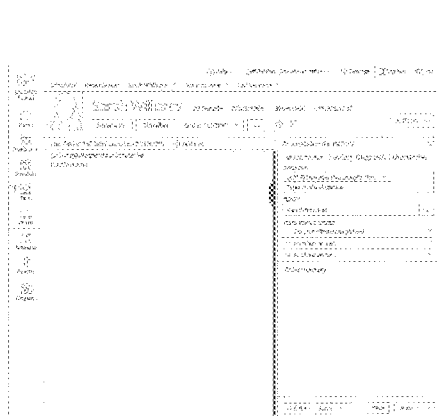
FIG. 5 is second image thereof; and,

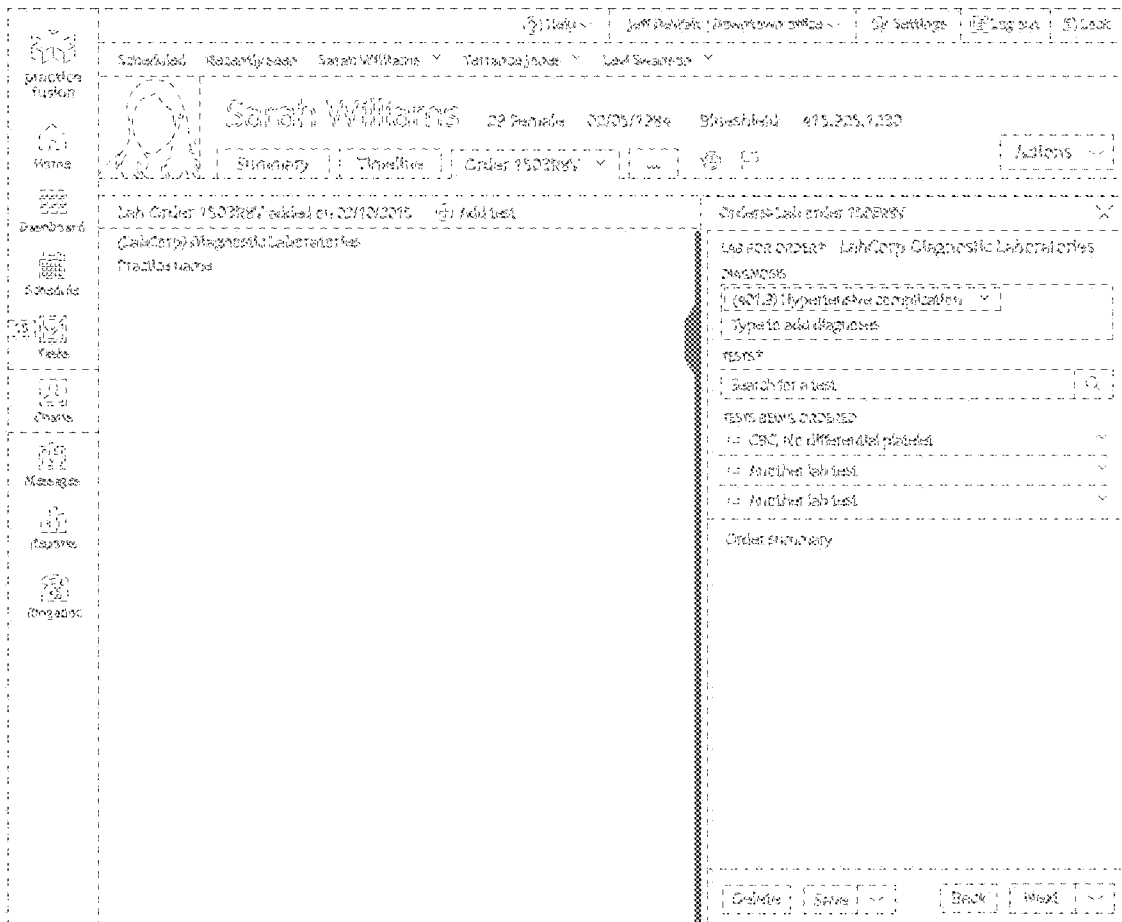

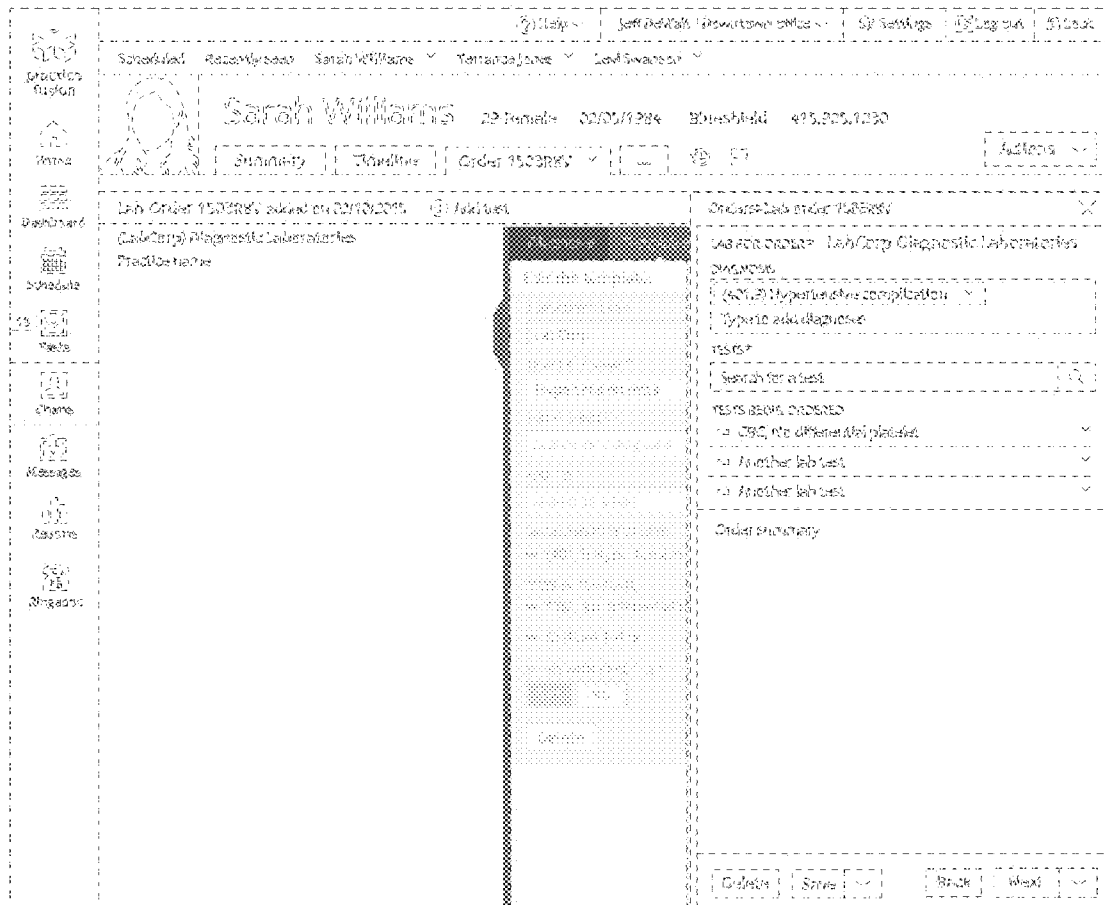

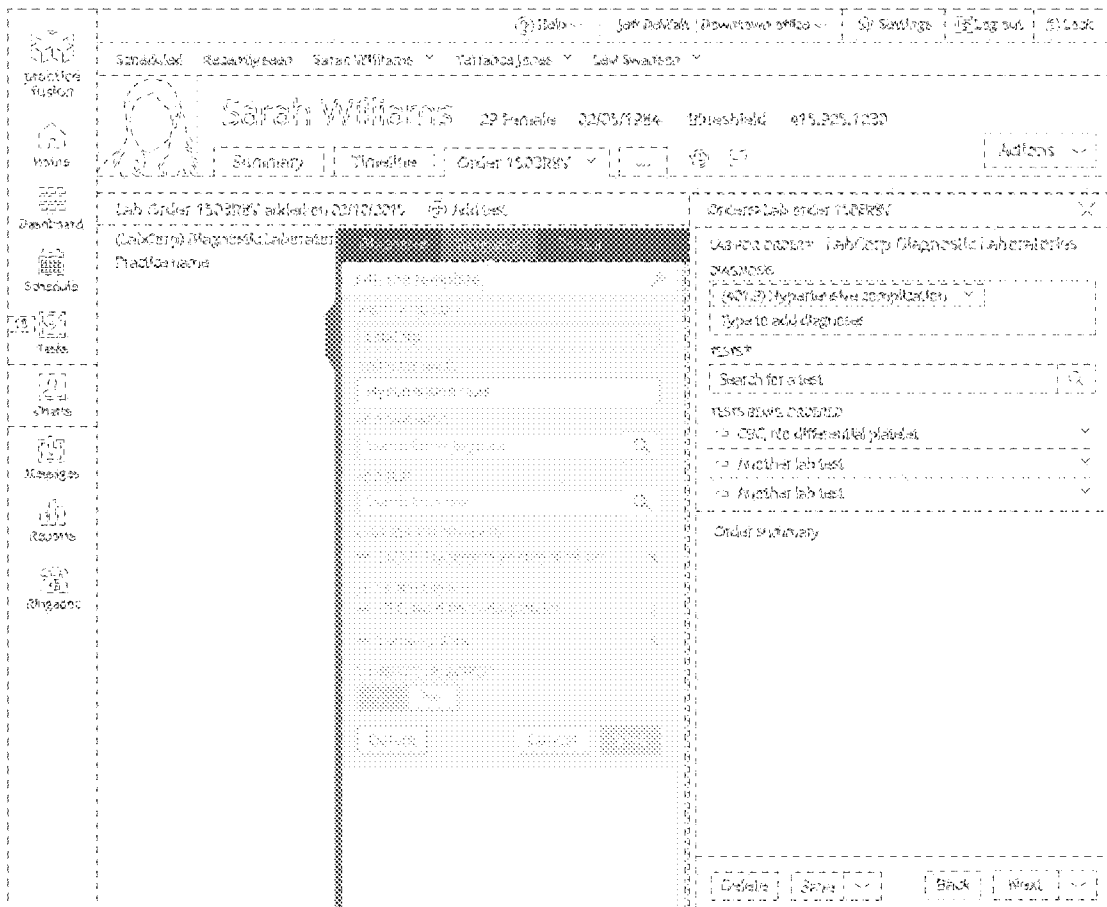
